AN ORDINANCE AUTHORIZING THE EXECUTION OF MODIFICATION NO. 1 TO AGREEMENT DATED JUNE 28, 2021 (RFQ NO. 2021-063) FOR PROFESSIONAL ENGINEERING SERVICES FOR WATER MASTER PLAN WITH BURNS AND MCDONNELL ENGINEERING COMPANY, INC., FOR AN INCREASE OF \$53,545 WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$303,245, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME.

WHEREAS, the City desires to enter into a modified agreement with Engineer to perform the work.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. That the Modification No. 1 of the agreement for professional engineering services by and between the Burns and McDonnell Engineering Company, Inc. and the City of Lee's Summit, Missouri for Water Master Plan Services, (RFQ No. 2021-063), a true and accurate copy being attached hereto and incorporated herein by reference as "Exhibit A", is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.
