Hello, My name is Abigail Novogoratz. I am a resident of Newberry and have lived here all of my life. I attended Sunset Valley and am excited to be attending East Trails Middle School. Because I reside within half a mile of school, I will be walking to school, and sometimes ride my bike. I am nervous because people are not always safe when they drive. Currently I see people drive fast on Newberry, 13th Street, Bailey, and Cape. They don't pay attention and commonly they are on their phones, barely looking up. With only two sidewalk entrances into the Middle School property at 13th street and Cape, this means that students who live between 13th and Cape will have to walk further to school by essentially backtracking. Therefore the

third sidewalk will be helpful in providing a safe route. I believe this is a valuable investment into the safety and equity of the students who reside within this walk zone. Please consider keeping the original plan in providing a sidewalk where 15th street originally was as this will be a safer option for us.

My friends and I acknowledge that in the winter, there will snow and ice when we go to school and we expect that it is our responsibility to walk responsibly to school or carpool. We know that not all of our neighbors will be able to clear the sidewalks and that is okay. We can be careful and responsible. We've already been doing that for years to go to our bus stops.
