

**BILL NO. 22-180**

AN ORDINANCE REPEALING SECTION 2-254 OF THE CODE OF ORDINANCES OF THE CITY OF LEE'S SUMMIT, MISSOURI AND ENACTING A NEW SECTION 2-254. APPLICATION FOR APPOINTMENT AND PROCESS FOR REAPPOINTMENT TO BOARDS, COMMITTEES AND COMMISSIONS – CONTENT. PROVIDING GENERALLY FOR THE INFORMATION REQUIRED FOR APPOINTMENTS OR REAPPOINTMENTS TO ANY CITY BOARDS, COMMITTEES, AND COMMISSIONS.

NOW, THEREFORE, be it ordained by the City Council of the City of Lee's Summit, Missouri, as follows:

SECTION 1. That a new "Sec. 2-254. Application for appointment to Boards, Committees and Commissions - Content." be repealed and a new "Sec. 2-254. Application for appointment and process for reappointment to Boards, Committees and Commissions – Content., be enacted to read as follows:

'Sec. 2-254. Application for appointment and process for reappointment to Boards, Committees and Commissions – Content.

- A. Initial Appointment. All persons wishing to be considered for appointment to any City board, committee, or commission shall first complete an application. The application shall include at least: name, address, e-mail address, telephone number, City Council District in which the person is registered to vote, years as a Lee's Summit resident, highest level of education completed, employment and position, reason for interest in appointment and any qualifications, involvement in other community activities, any boards, commissions or committees of interest, current service on any other City of Lee's Summit board, committee or commission and when the current term expires; and, past service on a board, committee or commission in Lee's Summit or any other community. The completed application shall be forwarded to the City Council prior to consideration of any appointment.
- B. Reappointment. All persons seeking reappointment shall be asked by staff to update the information included in the application listed in subsection A above. In the event that the person seeking reappointment does not have on file a previous application, that individual shall be asked to complete the application form. However, failure to update or provide such information shall not bar a person from being appointed or serving on the board, committee or commission. The original application and any updates shall be forwarded to the City Council prior to consideration of any reappointment.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage, adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
