B. 2022-5124 Discussion of 2023 Legislative Priorities

Brian Head gave a brief update regarding the Legislative Priorities that the previous Committee had last year. He went section by section giving information regarding items that may or may not have passed last year to help the Committee make decisions on what to focus on this year.

After general discussion, the Committee asked Brian to send them a memo that was done last year regarding local control of home based businesses and what that means for people who work from home or have a renter.

There was also discussion regarding developers who are faced with different regulations from different cities and how that can cause fragmented landscapes and loss of development for our community as they don't want to navigate through our regulations.

Councilmember Shields suggested adding bullet points to the Community Section of the brochure to keep it consistent with the rest of the document.

The Committee inquired about recognizing the Legislators that helped us get funding for the North PRI property improvements. This was mentioned at a previous Legislative Relations Committee meeting.
