AN ORDINANCE APPROVING AMENDMENT NO. 7 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2023, AS ADOPTED BY ORDINANCE NO. 9441, ORDINANCE NO. 9442, ORDINANCE NO. 9449, ORDINANCE NO. 9450, AND ORDINANCE NO. 9451, BY AMENDING THE AUTHORIZED PUBLIC SAFETY SALES TAX FUND EXPENDITURES FOR THE CITY.

WHEREAS, pursuant to Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451, on June 21, 2022, the City Council adopted the authorized expenditures for the City of Lee's Summit, Missouri, for the Fiscal Year ending June 30, 2023; and,

WHEREAS, on April 5, 2022 the citizens of the City of Lee's Summit, Missouri approved a ½ cent Public Safety Sales Tax; and,

WHEREAS, with the approval of Ordinance No. 9517 and Ordinance No. 9518 by the City Council, the Police and Fire Departments have begun recruitment efforts for the approved positions; and,

WHEREAS, the Police and Fire Department staff have developed a plan to spend the additional funds as promised to the citizens to include additional staff, equipment, and training in alignment with Ordinance 9323 passed January 11, 2022; and,

WHEREAS, to enable the Police and Fire Departments to proceed the current fiscal year budget needs amended.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Police and Fire Departments authorized expenditures for the Fiscal Year ending June 30, 2023, of the City of Lee's Summit, Missouri, are amended as set forth in Exhibit A and incorporated herein by reference.

SECTION 2. All other provisions of Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 9482), Amendment No. 2 (Ordinance No. 9497), Amendment No. 3 (Ordinance No. 9517), Amendment No. 4 (Ordinance No. 9518), Amendment No. 5 (Ordinance No. _____), and Amendment No. 6 (Ordinance No. _____).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
