Description of Applicant's Request

The City is realigning its Boards and Commissions to implement the new Strategic Plan. This amendment moves the Historic Preservation Commission into the new Cultural Commission.

4. Analysis

Background

- The City participates in the Missouri State Historic Preservation Office's Certified Local Government Program (CGL).
- As a CGL, the City gains valuable access to state funding resources and technical assistance support as well as recognition for upholding historic preservation best practices.
- The Boards and Commissions reorganization process recommends sunsetting the Historic Preservation Commission.
- Staff recommends authorizing the new Cultural Commission to assume the role of the Historic Preservation Commission so that the City can maintain its CGL status without interruption support or services.

- To maintain our status, we need to maintain the following program requirements:
 - Establish by ordinance, and maintain, an adequate and qualified historic preservation review commission.
 - The commission must have a least five members.
 - To the extent possible, have a membership that represent professions applicable to maintaining local history and historic preservation. (Ex: architecture, archeology, urban design, cultural geography, conservation, landscape architecture, etc.)

Comprehensive Plan

The new Cultural Committee joins are existing Arts Committee, Beautification Commission and Historic Preservations Committee. This creates an opportunity for people with different interests find related opportunities to celebrate and preserve the culture of Lee's Summit. The Comprehensive Plan supports the formation of this new committee through Quality of Life Goal: "Create a community that celebrates, welcomes and supports cultural, parks and recreational amenities." The UDO amendments shift the Historic Preservation Committee to a larger group with a wider focus on culture. The Comprehensive Plan advocates for celebrating the city's culture through recreational amenities like historic installations.

UDO Changes

- 1.) Amend Sec. 14.170. Historic Preservation Commission—Continuation.
 - "The Historic Preservation Commission is continued in accordance with the provisions of RSMo 253.415 and amendments thereto and shall be known as the <u>Cultural Commission</u>. For all <u>purposes the Cultural Commission for the City of Lee's Summit shall serve as the Historic Preservation Commission as described herein."
 </u>

2.) Repeal the following UDO Sections

- 14.180 Preservation Commission Membership, terms, vacancies.
- 14.190 Preservation Commission Commission Officers.
- 14.200 Preservation Commission Meetings.
- Pertinent items in these sections have been integrated as applicable into the Cultural Commission formation ordinance.
