AN ORDINANCE AMENDING CHAPTER 6, AVIATION, ARTICLE II, BOARD OF AERONAUTIC COMMISSIONERS OF THE CODE OF ORDINANCES OF THE CITY OF LEE'S SUMMIT MISSOURI REGARDING THE BOARD OF AERONAUTIC COMMISSIONERS.

WHEREAS, the City recently enacted Ordinance 9538, which sets forth new rules for the conduct of business by City boards, committees, and commissions; and,

WHEREAS, changes to the Board of Aeronautic Commissioners ("Board") are desired to align the Board with the current needs of the City and the Airport, other citizen boards of the City, and necessary to align the Board with Ordinance 9538.

NOW, THEREFORE, be it ordained by the City Council of the City of Lee's Summit, Missouri, as follows:

SECTION 1. Chapter 6, Aviation, Article II, Board of Aeronautic Commissioners, of the Code of Ordinances of the City of Lee's Summit, Missouri be amended to read as follows:

Sec. 6-21. Created.

There is hereby created the Board of Aeronautic Commissioners, hereinafter called the Board.

Sec. 6-22. Membership, appointments, and removal.

The Board shall consist of nine (9) voting citizen members who shall serve without compensation and, subject to the right of resignation or removal, hold their office for the term of three (3) years and until their successors are duly appointed and qualified. Any Board member as of January 1, 2023, shall be entitled to serve the remainder of their appointment subject to resignation or removal. Members of the Board should have a demonstrated interest, competence, or knowledge of aeronautics, finance, infrastructure, strategic planning, or other related field associated with aeronautics.

Sec. 6-23. Duties; powers.

The Board shall engage in public outreach related to the Airport. The Board may make recommendations for the Airport based on public outreach, the Airport Master Plan, the Airport Business Plan, and the approved Airport Budget The Board shall maintain a vision for the Airport to support the mission and goals of the City. The Board may make recommendations on rules and regulations for consideration by City staff and the Council regarding operations at the Airport. When appropriate, the Board may provide input for periodic updates to the Airport Master Plan and Airport Business Plan.

Sec. 6-24. Rules, policies, and procedures.

The Board, including its rules, policies, and procedures, shall be governed by all applicable Ordinances of the City, including Chapter 2, Article V, Division 1.

SECTION 2. It is the intention of the City Council and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lee's Summit, Missouri, and the sections of this Ordinance may be renumbered to accomplish such intention as deemed appropriate by the City Clerk or the codifier of the City's Code.

SECTION 3. This Ordinance shall be in full force and effect on and after January 1, 2023, after its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
