ARTICLE II. - BOARD OF AERONAUTIC COMMISSIONERS

Sec. 6-21. - Created.

There is hereby created the Board of Aeronautic Commissioners, hereinafter called the Board.

Sec. 6-22. - Composition.

The Board shall consist of nine (9) voting members as follows:

- A. A member of the Council appointed by the Mayor Pro-Tem with the advice and consent of a majority of the Council; and
- B. Eight (8) citizen members as appointed by the Mayor and approved by the Council.

Sec. 6-23. - Compensation.

All citizen members of the Board shall serve without compensation.

Sec. 6-24. - Terms; vacancies.

- A. Following enactment of this ordinance, two (2) citizen members of the Board shall be appointed in the year 2000 and shall serve a term commencing on the date of appointment and expiring on September 14, 2004.
- B. Two (2) citizen members of the Board shall be appointed in the year 2001 and shall serve a term commencing on the date of appointment and expiring on September 14, 2005.
- C. Two (2) citizen members of the Board shall be appointed in the year 2002 and each year thereafter and shall serve a term of four (4) years commencing on September 15, with two (2) members' terms expiring on September 14 each year.
- D. Subject to the right of resignation, all citizen members of the Board shall hold office for the term thereof, and until their successors are duly appointed and qualified.
- E. All citizen vacancies shall be filled for the unexpired portion of the term.

Sec. 6-25. - Chair; vice-chair.

The Board, on or before December 1 each year, shall choose a Chair and a Vice-Chair from among the citizen members. The terms of the Chair and Vice-Chair shall be for one (1) year with eligibility for reelection.

Sec. 6-26. - Meetings; rules of procedure; records.

The Board shall hold regular meetings, call special meetings as required, and shall adopt and from time to time amend rules of procedure for the transaction of business and keep a record of Board proceedings, which records shall be public records.

Sec. 6-27. - Budget.

The Board shall review the proposed budget for the Airport each year and make recommendations thereon to the Council. The budget shall be prepared in substantially the same manner as budgets for other City departments.

(Code 1988, § 6-27)

Sec. 6-28. - Duties; powers.

The Board shall provide guidance and direction to the City Manager and the City Manager's staff in the operation of the City's Airport. The Board shall review and make recommendations to the Council on all proposed contracts, agreements, rules, regulations, charges and fees, and other such matters as deemed appropriate by the Board and all Airport matters on which the Council requests a recommendation.

Sec. 6-29. - Airport rules and regulations.

The Board shall adopt such rules and regulations, approved by resolution of the Council, for use of the Airport as it deems necessary. Such rules and regulations shall be posted at the Airport and incorporated by reference into all contracts and rental agreements entered into.
