

## **BILL NO. 23-007**

AN ORDINANCE APPROVING AMENDMENT NO. 10 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2023, AS ADOPTED BY ORDINANCE NO. 9441, ORDINANCE NO. 9442, ORDINANCE NO. 9449, ORDINANCE NO. 9450, AND ORDINANCE NO. 9451, BY AMENDING THE FULL TIME EQUIVALENT POSITIONS AND AMENDING THE PAY AND CLASSIFICATION PLAN FOR THE CITY.

WHEREAS, pursuant to Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451, on June 21, 2022, the City Council adopted the authorized Full Time Equivalents (FTEs) for positions and the Pay and Classification Plan for the City of Lee's Summit; and,

WHEREAS, to provide adequate leadership in the Development Services Department, there is a need to add a Deputy Director of Development Services position to the Pay and Classification Plan; and,

WHEREAS, to maintain flexibility in the future to hire a Deputy Director or an Assistant Director of Plan Services, the current Assistant Director of Plan Services FTE will be reclassified to be filled by either a Deputy Director or Assistant Director of Plan Services, this would not be an additional FTE, only a re-classify of the Assistant Director of Plan Services FTE; and,

WHEREAS, this action will not need an increase in the current fiscal year budget, current year savings will cover the expense; and,

WHEREAS, this action will not increase the number of FTEs or authorized expenditures for the Development Services Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Fiscal Year 2022-23 Development Services Department Full Time Equivalents for a certain position and amendment to the Pay and Classification Plan, as adopted Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451 is hereby amended as set forth in Exhibit A Pay and Classification Plan and Exhibit B Development Services FTE, attached and incorporated herein by reference.

SECTION 2. All other provisions of Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 9482), Amendment No. 2 (Ordinance No. 9497), Amendment No. 3 (Ordinance No. 9517), Amendment No. 4 (Ordinance No. 9518), Amendment No. 5 (Ordinance No. 9542), Amendment No. 6 (Ordinance No. 9543), Amendment No. 7 (Ordinance No. 9544), Amendment No. 8 (Ordinance No. 9568), and Amendment No. 9 (Ordinance No. 9569).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
