A. 2023-5399 Approval of the January 11, 2023 Community and Economic Development Action Letter.

B. BILL NO.

<u>23-038</u>

An Ordinance amending Section 29-41 of the Code of Ordinances for the City of Lee's Summit, Missouri, Governing the Public Safety Advisory Board Establishment and Duties. (CEDC 2/8/23)

Police Chief Travis Forbes, stated this ordinance is basically changing the voting membership of the Public Safety Advisory Board by removing the City Council Liaison as a voting member.

A motion was made by Councilmember Lovell, seconded by Councilmember Prier, to recommend for City Council approval an Ordinance amending Section 29-41, of the City of Lee's Summit, Missouri, Public Safety Advisory Board Established Duties.

C. 2023-5405 Presentation: Police Department automated license plate readers.

Police Chief Travis Forbes stated the City of Lee's Summit currently has one mobile license plate reader but wants to add the use of Automated License Plate Readers (ALPR). He described the technology, provided examples of use, along with the benefits and concerns of using it. The City's Ordinance 7386 pertains to license plate readers but one of the provisions restricts the use of fixed license plate readers.

After discussion, there was a consensus by the committee to support repealing Ordinance 7386 and direct staff to draft an ordinance for City Council approval allowing fixed license plate readers with additional provisions as discussed.

D. 2022-5243 Presentation: Accessory Dwelling Unit (ADUs)

Shannon McGuire, Planner, reviewed the 2020 Ignite Comprehensive Plan which identified Strong Neighborhoods and Affordable Housing as potential goals. One way to achieve these goals is through ADU's. Mr. McGuire described types of ADU's and provided diagrams and photos. He also noted the positive and negative effects of ADU's. He explained the current zoning ordinance for ADU's and noted the current process for approving ADU's is cumbersome. Discussion

ensued followed by a consensus of the committee to direct staff to draft an ordinance on ADU's with provisions as discussed.

E. 2022-5240 Presentation: Minor Plats

Josh Johnson, Director of Development Services, explained that currently a mandate is required from an elected body to make changes to infrastructure improvements on minor plats.

Staff is seeking the committee's approval to clarify what public infrastructure improvements are required for minor plats. Following discussion, there was a consensus by the committee to direct staff to draft an ordinance to address this issue for the committee's review.

F. 2023-5442 Presentation: Annual update on Pro-active Code Enforcement (PACE)

Dan Harper, Assist. Director of Field Services, provided an update on the Pro-Active Code Enforcement which included history, highlights, outcomes and statistics of the program.

G. 2022-5237 Presentation: Infill Policy Discussion

Due to time constraints, this item was tabled and will be discussed at a future Community and Economic Development Committee meeting.

6. Roundtable

Chair Edson stated she would like staff to research possible incentives for affordable housing and asked the committee for their input.

After discussion, there was a consensus by the committee to direct staff to research and bring forward information about affordable housing including definitions, current housing market analysis and metrics, and ways to decrease costs for homeowners.

7. Adjournment

Chair Edson adjourned the meeting at 6:34 p.m due to lack of quorum. (Councilmember Shields and Councilmember Lovell left the meeting.)
