Special Legislative Topics:

- 291 N interchange and MSHP funding
- KCMO Landfill
- MoDOT funding (trash/mowing/ROW maintenance)

291 North Interchange and MSHP funding:

Funding Gap of 6.7 million for the project - There was a consensus from the committee to have staff continue to work with State representatives to try to receive additional funding from the State officials for the relocation of the State Highway Patrol office.

KCMO Landfill:

City Council unanimously approved a resolution to oppose the landfill location. Mayor Baird is going to Jefferson City to attend a public hearing. Another Pubic hearing regarding landfill will be held on February 16, 2023 and staff will attend the Raymore hearing. This discussion was geared toward opposing the location for this landfill and for informational purposes only. No direction from the committee was needed.

MoDot funding (trash, mowing/ROW maintenance):

The challenges facing MoDot are resources. There is not enough staff to address this issue. MoDot has higher priorities and the City would have too many legal and liability issues to do this work. The Committee discussed having volunteers help or doing a cost share with the state due to the State's funding issues. Also discussed, was having the State give the City funding to mow these areas, however, with increased costs, funding was still an issue. Mayor Baird informed the Committee that there is discussion regarding the "Clean Team" on a future agenda, which will be a PowerPoint presentation to the community on what the City is doing to resolve this issue. No committee direction needed.

Infrastructure Funding:

There is \$9 billion in State funding. Staff will look at the different funding categories to see if Lee's Summit qualifies for such funding. Infrastructure funding is geared towards transportation and road related projects. The Committee agreed to take a proactive approach and prepare a presentation to request funding for I-470 expansion.
