Interest Response: As part of the Planning Commission for the past 4 years, I've had the opportunity to grow as both a citizen of Lee's Summit and a civil servant to its citizens. I've had the pleasure of serving the City and being part of the some of the most important decisions made for the development and creation of jobs, infrastructure, and commerce to date. The vast and fast growth of the City of Lee's Summit has had a huge impact on every person within its limits, but also on the Kansas City metro area as a whole. I've had the great honor of being part of that for the past 4 years and would be happy to continue service to my fellow citizens and city for another 4 years if it pleases the Mayor and City Council.

As part of my tenure, I've believe I've been an asset in asking the correct questions of developers, architects, business leaders, and all interested parties as they presented various projects and concepts to the Planning Commission. Some notable items include the development of Elevate 114 Apartments in downtown Lee's Summit. This project was a source of contention for many in the city, with a TIF Commission split down the middle. downtown. I very much believe that the best decision are made with an open mind and hearing every voice involved, but conclude decisively and with a collaborative decision.

Another project which comes to mind is the development of East Trails Middle School. As part of the project, LSR7 desired the City of Lee's Summit to pay approximately \$2 million for a roadway around the school. I was firm in my conviction that it was the incorrect course of action. With any other developer, the City would never have submitted funds directly for an improvement almost exclusively benefitting the developer. I submitted the denial and was backed by much of the Planning Commission passing the vote. Two weeks later, LSR7 submitted and funded the road on their own. While a great partner, LSR7 was incorrect in their request. I believe that a strong, friendly voice is always needed on the Planning Commission and I pledge to continue to help all our partners make the best decisions for Lee's Summit with a firm stance and helping smile.

I am small business owner here in Lee's Summit and believe my experiences as such play a large role in my dedication to a healthy, broad tax base within the city. Healthy cities require a mix of housing choices, industrial capabilities, clean and repaired infrastructure, and retail availability in order thrive. Growing the City is a function of both design and attractiveness. We can't expect to grow if we don't offer citizens and businesses a healthy environment. I've excitedly over the past 4 years welcomed many businesses of all sizes into the City, while diligently working to weed out any bad conceptions. We've happily increased not only our industrial options across Lee's Summit, but have kept our retail sector healthy along the way, and very attractive as a destination for many shops and companies. Our housing sector is well-managed and positioned to be one of the healthiest in the Kansas City area, with options available for all families. I am aware that issues exist with our housing, but happy to say that I believe I've helped this issue over my term and intend to continue promoting safe, smart development in the future.

I believe that I have been of service as a Planning Commissioner to the City of Lee's Summit and I would love the opportunity to do so for another 4 years. I believe that my dedication, experience, and personal background will serve the City well and help see another term of successful development and wise choices in the face of any adversity.

Other Activities: I currently serve my faith as a volunteer member of the ley clergy (Bishopric) in the Lee's Summit 1st Ward (congregation). As such, I act as part of the Administration for the Ward and serve multiple religious roles. It is what's referred to as a "calling" in our faith and I happily fulfill it, but it will end, usually between 3 to 5 years in service.
