B. 2023-5514 Review of Lobbyist Report

Brian gave an overview of a couple of items from the Lobbyist report. Specifically:

- 1. Video service provider bill. There is a lawsuit in progress that will push timeline out for cities to collect taxes on streaming.
- 2. HB909 Landfill Bill regarding jurisdiction not assigned to Committee yet.
- 3. SB131 Exempts guns, ammunition and also food from local sales tax will cost cities.

There was a question about funding for the State Highway Patrol relocation. Mr. Head informed the Committee that the Lobbyist and Staff are trying to find funding sources, however, there is no solution at this time.

Mr. Head asked the Committee if they would like the Lobbyist to come to the next Legislative and Intergovernmental relations Committee meeting (via zoom) to provide an update as part of his contractual agreement to inform the City twice a year. The Consensus of the Committee was affirmative.

6. Roundtable

Mayor Baird gave a brief report on the City's trip to National League of Cities. He felt the program was informative but mentioned they were unable to meet with the Representatives and met with their staff instead.

Councilmember Lovell mentioned that Senator Hawley (Representative who lives in Kansas City) was at the recent Chamber Governmental Relations Committee meeting and offered to assist us in the future when possible.

The next meeting of the Committee is scheduled for May 8, 2023 via zoom.
