## **SURROUNDING ENVIRONMENT** (Streets, Developments)

The proposed development is located southeast of I-470 and NW Main St. The project site is bounded by I-470 to the north, NW Main St. to the west, the Lee's Summit North railroad spur to the south, and Saint Luke's Hospital to the east. The surrounding property is a mix of existing and planned Industrial and commercial development.

#### **ALLOWABLE ACCESS**

The subject development has planned two access points: 1) one from a proposed driveway extension off NW Victoria Dr as the main access point; and 2) one emergency-only access point along NW Main St. The main access point from NW Victoria Dr will be located approximately 1,800 feet east of NW Main St. The second point of access will be located along NW Main St. approximately in the middle of their property line and will be gated for emergency-access only.

# **EXISTING STREET CHARACTERISTICS** (Lanes, Speed limits, Sight Distance, Medians)

NW Main St is currently a two-lane, undivided commercial collector with a 35-mph speed limit. Following the construction of the approved Lee's Summit Logistics development, NW Main St will be improved to include a center two-way-left-turn-lane (TWLTL), sidewalk, and curb and gutter south of the railroad spur. NW Main St., from the spur, north and adjacent to the subject development, to NW Colbern Rd is considered an unimproved road.

NW Victoria Dr is a two-lane, undivided commercial collector with a 25-mph speed limit. The cross-section of NW Victoria Dr is currently constructed with two 15' lanes with curb and gutter from NW Main St to NE Douglas St with intermittent sidewalk.

The intersection of NW Victoria Dr and NE Douglas St is signal-controlled while the intersection of NW Victoria Dr and NW Main St is stop-controlled on NW Victoria Dr. The intersection of NW Main St and NW Tudor Rd is also stop-controlled and will remain that way following the completion of the Lee's Summit Logistics development. The intersection of NW Main St and NE Colbern Rd is currently stop-controlled.
