What is the Capital Improvement Plan (CIP)

❖ The CIP is both a Plan and a Budget

- ❖ Five-year Planning Document that annually amends the Comprehensive Plan
- ❖ Fiscally constrained: all project supported by known revenue source and limited by projected revenues
- ❖ Long-lasting, public infrastructure projects that include Roads, Water, Sewer, Buildings/Facilities, Parks, IT Networks
- ❖ Local Practice: Projects greater than \$75,000 that exceeds the administrative approval limit in the Procurement Policy
- ❖ Funding shown in FY2024 are adopted as part of the City's annual budget for FY24

State Statutory Definition: (RSMo 447.700)

"Public capital improvements", capital improvements or facilities owned by a governmental agency and which such agency has authority to acquire, pay the costs of, maintain, relocate or operate, or to contract with other persons to have the same done, including but not limited to, highways, roads, streets, electrical, gas, water and sewer facilities, railroad and other transportation facilities, and air and water pollution control and solid waste disposal facilities.



❖ FY24 CIP Highlights

- ❖ Total 5-year funding estimated at \$624 million
- ❖ Closing 17 projects totaling \$16 million
- ❖ Adding 31 new projects estimated at \$155 million
- ❖ FY24 CIP includes projects approved by voters as part of the April 2023 No Tax Increase Bond Issue

❖ Process to address public comments related to new projects

- ❖ Previously Committed projects and programs remain committed
- ❖ Update costs due to inflation or annual program cycles based on infrastructure conditions
- ❖ Review cash flow capacity
- ❖ Assess projects recommended by Public Works Committee

Major Dedicated Funding Sources

- ❖ CIP Sales Taxes approved by voters
 - ❖ Renewed in 2017 for 15 years (sunsets in 2032)
 - ❖ Streets, bridges, signals, lighting and stormwater projects
- ❖ Transportation Sales Tax
 - ❖ Annual Pavement Management Programs
 - ❖ Right of Way (ROW) Infrastructure Rehabilitation
 - ❖ Traffic Programs
 - ❖ Transportation Projects
- ❖ Parks & Rec Sales Tax and User Fees
- ❖ Water & Sewer Tap Fees and Billing Rates

Major Dedicated Funding Sources

- ❖ General Obligation Bonds approved by voters
 - ❖ Dedicated to specific projects or project types listed in the ballot language
 - ❖ Current projects: Fire Station #4, Fire Station #5
 - ❖ April 4, 2023 No Tax Increase Bond Issue (\$186 million over ten years)
- ❖ Use Tax
 - ❖ Mirrors Dedicated sales taxes
 - ❖ Parks, CIP Sales Tax Renewal, Transportation
- ❖ TIF/TDD

Major Dedicated Funding Sources

❖ State & Federal Grants

- ❖ Most common grants are for Airport and Streets
- ❖ Other grants received for Stormwater, Sanitary Sewer
- ❖ Community Bus Service Program – ATA/OATS

❖ Excise Tax

- ❖ Tax paid by development or re-development that increases traffic
- ❖ Limited to street projects
- ❖ Annually reported to the License Tax Review Committee

 - ❖ Evaluate existing conditions in context of Strategic Plan
 - ❖ Evaluate infrastructure growth as to how a project or program supports the iGNITE comprehensive plan
- ❖ Review public comments, Council comments, and other sources of input from the past year(s) (i.e. FY23 CIP Comments)
- ❖ City Staff evaluated using guidance from Council
- ❖ Review, discuss and confirm with Public Works Committee
- ❖ Submit summary report to full Council
