AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 22-109A-1 FOR THE REHABILITATION OF RUNWAY 11-29, TAXIWAY B AND TAXIWAY C TO SCODELLER CONSTRUCTION, INC. IN THE AMOUNT OF \$614,498.45, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the joint seal and pavement rehabilitation project is an integral piece of the Airport's pavement maintenance program required to maximize the useful life of the Airport's pavements; and,

WHEREAS, funding for this project is provided through a Federal Grant and the City's Transportation Sales Tax; and,

WHEREAS, Public Works Engineering issued an advertisement for bids for the construction of Project No. 22-109A-1 on May 9, 2023, guided by local policies and state statutes; and,

WHEREAS, Scodeller Construction, Inc. ("Contractor") was determined to be the lowest and best bidder by City staff; and,

WHEREAS, the City and Contractor desire to enter into an agreement to perform the services for Project No. 22-109A-1; and,

WHEREAS, the City Manager is authorized and empowered by the City to execute contracts providing for construction services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 22-109A-1 to the Contractor in the amount of \$614,498.45.

SECTION 2. The agreement between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as Exhibit A and incorporated by reference, is hereby approved and the City Manager, or designee, is hereby authorized to execute an agreement substantially similar to the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
