

## **BILL NO. 23-195**

AN ORDINANCE AMENDING THE BYLAWS OF THE LEE'S SUMMIT VISITORS BUREAU A MISSOURI 501(C)(6) CORPORATION IN LEE'S SUMMIT, MISSOURI.

WHEREAS, the City Council approved the bylaws on August 22, 2023; and,

WHEREAS, after that approval staff recognized an inconsistency and error in Article II, Section 2 due to an oversight in editing of drafts prior to approval; and,

WHEREAS, the bylaws should be amended to correct the oversight.

NOW, THEREFORE, be it ordained by the City Council of the City of Lee's Summit, Missouri, as follows:

SECTION 1. Article II, Section 2 of the Bylaws of the Lee's Summit Visitors Bureau be repealed and replaced in its entirety and replace with the following new section:

Article II, Section 2

The Board of Directors shall consist as follows:

Six (6) directors nominated by the Mayor, including:

- One (1) representative from lodging/hotel interests
- One (1) representative from restaurant/dining interests
- One (1) representative from the Lee's Summit Cultural Commission
- One (1) representative from sports/recreation interests
- Two (2) At-Large representatives who are associated with the tourism, hospitality, entertainment industries, attractions, retail, finance, or special events, and who have demonstrated an interest in Lee's Summit and its tourism promotion program.

One (1) director nominated by Downtown Lee's Summit Main Street Board

One (1) director nominated by the City's designated Economic Development Office board

One (1) director nominated by the Lee's Summit Chamber of Commerce Board

Three (3) directors that are relevant City of Lee's Summit Staff members, including a representative from the City Manager's Office, nominated by the City Manager

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage, adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
