AN ORDINANCE APPROVING MODIFICATION NO. 2 TO THE ON-CALL AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES (ORIGINAL RFQ NO. 2022-030) BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND OLSSON ASSOCIATES, INC., IN THE AMOUNT OF \$96,540.00, FOR PROFESSIONAL ENGINEERING SERVICES FOR THE I-470 SEWER CROSSING DESIGN AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME.

WHEREAS, the City and Olsson Associates, Inc. ("Engineer") entered into an on-call agreement dated January 30, 2023 (RFQ No. 2022-030) for On-Call Professional Engineering Services ("On-call Agreement"); and,

WHEREAS, the City desires to engage the Engineer for a specific scope of engineering services which are covered by the On-call Agreement; and,

WHEREAS, the Engineer has submitted a proposal for the engineering services and an estimate of engineering costs to perform said services in compliance with the On-call Agreement; and.

WHEREAS, the City Manager is authorized and empowered by the City to execute contracts providing for professional engineering services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves Modification No. 2, attached hereto and incorporated herein by reference as Exhibit 1, to the Oncall Agreement for a not to exceed amount of \$96,540.00.

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the City Manager, or designee, to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
