AN ORDINANCE AUTHORIZING AN AMENDMENT TO PERMIT THE EXTENSION OF THE PROJECT TIME PERIOD FROM OCTOBER 15, 2016 TO DECEMBER 30, 2017 OF THE STATE BLOCK AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION, GRANTING STATE FUNDS IN THE AMOUNT OF \$6,807,158.00 FOR RUNWAY 18-36 EXTENSION PREGRADING AT THE LEE'S SUMMIT MUNICIPAL AIRPORT.

WHEREAS, the parties entered into an Agreement executed by the Sponsor on September 23, 2015, and executed by the Commission on October 8, 2015, (hereinafter, "Original Agreement") under which the Commission granted the sum not to exceed Six Million Eight Hundred Seven Thousand One Hundred Fifty-Eight Dollars (\$6,807,158) to the Sponsor to assist with Grading for Runway 18/36 Extension and established a project time period through October 15, 2016; and,

WHEREAS, this State Block Grant is in the amount of \$6,807,158.00 (funding 90% of the cost of the construction and inspection for the Project) and is to be used for the costs of the Project; and,

WHEREAS, local matching funds of \$378,176.00 (5% of the Project cost) are required and are available from the Airport Construction Fund; and,

WHEREAS, the parties both desire to extend the project time period in order to allow for completion of the work which will require an amendment to the original agreement.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the Mayor on behalf of the City of Lee's Summit, of a state block grant agreement amendment to extend the time to complete the project outlined therein by and between the Missouri Highways and Transportation Commission and the City of Lee's Summit, Missouri for runway 18-36 extension pregrading at the Lee's Summit Municipal Airport, which is attached hereto and incorporated by reference as if fully set forth herein.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
