AN ORDINANCE AUTHORIZING EXECUTION OF MODIFICATION NO. 1 TO THE AGREEMENT WITH GEORGE BUTLER ASSOCIATES, INC FOR PROFESSIONAL ENGINEERING SERVICES FOR SW JEFFERSON ST. (PERSELS RD TO OLDHAM PKWY)(RFQ NO. 419-32272) IN THE AMOUNT OF \$27,838.00 FOR A REVISED NOT TO EXCEED CONTRACT AMOUNT OF \$299,952.00, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME; AND, CONTAINING AN EMERGENCY CLAUSE.

WHEREAS, City and Engineer entered into an agreement for professional engineering services with George Butler Associates, Inc. (RFQ No. 419-32272)(Base Agreement); and,

WHEREAS, Additional Professional Services are required to be completed for the Jefferson Street Improvement Project; and,

WHEREAS, City and Engineer desire to modify Articles I and IV of the Base Agreement to provide specific services required for the Jefferson Street Improvement Project and establish a not to exceed rate for those tasks and services; and,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby approves Modification No. 1 to the Agreement for professional engineering services for SW Jefferson St. (Persels Rd to Oldham Pkwy)(RFQ No. 419-32272), by and between the City of Lee's Summit and George Butler Associates, Inc., generally for additional design associated with Jefferson Street and Persels Road, attached hereto and incorporated by reference as if fully set forth herein, for an increase of \$27,838.00 and a revised not to exceed amount of \$299,952.00, and authorizes the execution of the same by the City Manager.

SECTION 2. That this Ordinance approving Modification No. 1 to the agreement with George Butler Associates Inc. is necessary for the immediate preservation of public property, health and safety and is an emergency within the meaning of Section 3.13(f)(1) and (6) of the Charter of the City of Lee's Summit, Missouri, and, the same shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
