Why interested: I am interested in serving on the Public Safety Advisory Board as I believe I can contribute my experience in executive management and organizational development to effect positive outcomes for the city and public safety officials in our community. As an entrepreneur in the community, I have built an organization with gross revenue in excess of \$100MM annually that directly employs 60 full time staff members, and indirectly employs hundreds of employees. In 2016, I sold that organization (Summit Homes) to Clayton Homes, a Berkshire Hathaway affiliate. Today, I remain president of Summit Homes and also personally own and manage a number of other companies with real estate assets valued in excess of \$55MM, most located in Lee's Summit. I served as a commissioner on the Lee's Summit Planning Commission from April 2009 through April 2017. I earned a Bachelor of Science in Marketing Degree from Fort Lauderdale College (93') and a Master of Business Administration Degree from Nova Southeastern University (95'). I have previously served as a director for the National Association of Homes Builders Board of

Directors (2010-2017), a board member for the Home Builder's Association of Greater Kansas City (2008-2017), and as President of the Homes Builder's Association of Greater Kansas City (2013).

Other participation: I served as a Lee's Summit Planning Commissioner from 2009-2017. I support through donations the Lee's Summit Historical Society and the Lee's Summit Folk Festival.
