Ms. Geraldine Amato spoke in opposition to the application. Her comments included building over land that could be used for growing food, the segregation of elders into senior living facilities and wireless communication towers.

Ms. Sandra White spoke in opposition to the application. She reported a need for a gas station in the area.

Ms. Erica Vega spoke in opposition to the application. Her concern is the sanitary sewer easement that would go through her property to connect the five households currently on septic systems. She stated it equates to taking a quarter of an acre of her land. The easement would run through one of her driveways and between her two properties preventing her from building a retirement home in the center. It would require the removal of several mature trees and would go through her garden, fruit trees, berry bushes and grape

vines. It would also require construction equipment be allowed between both properties creating a danger and hardships for her children. She shared her objection to the easement in it's current form.

Ms. Jocelyn Hall spoke in favor of the application. She lives in one of the homes still on septic systems and she shared her appreciation to the developer for trying to get them connected to the sanitary sewer system.

Bond Issue; especially with the renewal of the Park's Sales Tax in 2016, the CIP Sales Tax in 2017 and the Finance and Budget Committee discussions regarding bonding capacity if there were a need to take an item to a vote in 2019. He stated that it has been five years since the voters have approved an outdoor performance space which has not been accomplished. There is a partnership with the Downtown CID who has committed money to partner on a Market Center. There are items being looked at for no tax increase bonding capacity. Development is happening in all parts of the city so some thought needs to be given to the infrastructure, the roadways and the things that make the City developable today and into the future.

Mayor Pro Tem Lopez said that as the year draws to an end, it has been an honor to work with staff and it has been a learning experience. It has also been an honor to serve with his colleagues on the dais. It's been a great 2018 and he looks forward to 2019, Happy Holidays.

Councilmember Forte commented to the Mayor that he has brought a real level of leadership and it has been appreciated. She added that he is doing a great job.

Mr. Steve Arbo, City Manager, recognized several staff members for their hard work and dedication while working through several difficult projects on this agenda.
