AN ORDINANCE APPROVING AMENDMENT NO. 1 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, BY REVISING THE AUTHORIZED EXPENDITURES FOR THE CITY OF LEE'S SUMMIT TO FUND A LIGHTNING DETECTION SYSTEM.

WHEREAS, The annual budget planning process includes a period for reviewing and revising anticipated expenditures for the upcoming fiscal year; and,

WHEREAS, at the May 20, 2019 Finance and Budget Committee meeting, a motion was made and passed which stated that the Finance and Budget Committee will recommend to the full City Council for approval the City Manager's Fiscal Year 2020 Budget as presented by the City Manager with the addition of \$17,500 for a lightning detection system for use by the Parks and Recreation Department; and,

WHEREAS, there is a one-time capital expense and an ongoing service charge related to the purchase of lightning detection equipment; and,

WHEREAS, future service charges will be reimbursed after a cost recovery rate is determined; and,

WHEREAS, the funding source for the initial purpose and first year service charge was determined to be funded from the General Fund; and,

WHEREAS, additional expansion requests remain unfunded and may be presented to the Mayor and Council for funding consideration at a future date.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the authorized expenditures for the Fiscal Year 2019-2020 of the City of Lee's Summit, Missouri, are amended in the manner shown as follows:

SECTION 2. All other provisions of Ordinance ____ shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. ____),

SECTION 3. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. That should any section, sentence, or clause of this ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
