#### 3. Council Roundtable

Councilmember Forte said that she attended the 10 year anniversary of Sunset Valley Elementary School and was able to give them a proclamation from the Mayor and they really appreciated that.

Councilmember Edson stated that she and Mayor Pro Tem Lopez had their first town hall forum for District 3 and it went very well and it was well attended. She thanked staff for attending and having great presentations.

Councilmember DeMoro advised that he, Councilmember Binney and some staff members were able to attend the Summit Tech Academy students final presentation of their plan for the airport. He also noted this was Dr. Paul Rutherford's last presentation as he is retiring.

Councilmember Faith talked about the annual Drug Take Back program that was held at the end of April at John Knox Village, Lee's Summit Medical Center, Lee's Summit Police Department and the Jackson County Sheriff's Department. He stated when this program first began, 60 - 80 pounds of medication were taken back and disposed of per site. This year John Knox Village took in 224 pounds, Lee's Summit Medical Center took in 198.5 pounds, Lee's Summit Police Department took in 180.2, and the Jackson County Sheriff's Department took in 114.5 for a total of 713 pounds and 6 ounces. He thanked all the volunteers and public safety officers that took time to make this possible.

Councilmember Binney said the Downtown Rotary Club is hosting Brewfest this Saturday, May 11 in downtown Lee's Summit that benefits Lee's Summit Social Services and several other non-profits. He also stated he received and email today inviting everyone for the grand opening of the Rock Island Trail from Jackson County on June 1st at 10am.

Councilmember Binney acknowledged and thanked Boy Scouts that were in attendance working on a merit badge.

Councilmember Johnson invited citizens to attend the ground breaking of a new library by Lee's Summit Medical Center as promised in the 2016 elections on 9:30 am on Friday, May 10th.

Mayor Baird stated Dr. Rutherford had a tribute ceremony at Missouri Innovation Campus (MIC) and it was very impressive and he was well recognized and thanked for this contributions to the city. Also, at MIC, Dr. Roger Best was recognized for being the new president of UCM and Mayor Baird feels he will be a great partner for the City. He stated they also discussed strategic planning at MIC and they were excellent work sessions.
