AN ORDINANCE APPROVING AMENDMENT NO. 3 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, AS ADOPTED BY ORDINANCE NO. 8643 AND ORDINANCE NO. 8652, BY AMENDING THE AUTHORIZED ALLOCATION OF FULL TIME EQUIVALENTS FOR CERTAIN POSITIONS WITHIN THE DEVELOPMENT SERVICES DEPARTMENT.

WHEREAS, Ordinance No. 8643 and Ordinance No. 8652, passed by the City Council on June 11, 2019, adopted the City's Budget for the Fiscal Year ending June 30, 2020; and,

WHEREAS, the documents included as part of the budget listed the number and type of full time equivalents for each department; and,

WHEREAS, it is necessary for the successful operation of the Development Services Department to convert two Permit Technician positions to two Development Technician positions and convert a Planner position to a Staff Engineer position; and

WHEREAS, this action will not amend the total expenditures or the total number of Full Time Equivalents for the Development Services Department.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Fiscal Year 2019-2020 Development Services Department full time equivalents for certain positions, as adopted by Ordinance No. 8643, is hereby amended as outlined in Exhibit A and incorporated herein by reference.

SECTION 2. All other provisions of Ordinance No. 8643 and Ordinance No. 8652 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8653) and Amendment No. 2 (Ordinance No. 8660).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
