AN ORDINANCE ADOPTING THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) 2020-2024 CONSOLIDATED PLAN OF THE CITY OF LEE'S SUMMIT AND AMENDING THE CITY OF LEE'S SUMMIT CITIZEN PARTICIPATION PLAN.

WHEREAS, in August of 1994, the City of Lee's Summit, Missouri ("City") was designated as an Entitlement Community eligible to receive Community Development Block Grant (CDBG) funding by the Department of Housing and Urban Development (HUD); and,

WHEREAS, during the months of September and October 2019, the City conducted a communitywide public consultation and engagement process to draft the 2020-2024 Consolidated Plan by identifying community needs, prioritizing those needs and devising strategies and actions to address the high priority needs; this process included public surveys, focus group discussions, public open houses and a public hearing; and,

WHEREAS, the City has prepared a 2020-2024 Consolidated Plan (the "Consolidated Plan"), as required by HUD; and,

WHEREAS, the City previously adopted a Citizen Participation Plan, as required by HUD, as a part of its 2015-2019 CDBG Consolidated Plan; and,

WHEREAS, on November 13, 2019, the Community and Economic Development Committee of the City Council conducted a public hearing to consider the Consolidated Plan, including the amended Citizen Participation Plan, and thereafter recommended that the City Council adopt the Consolidated Plan; and,

WHEREAS, on December ___, 2019, the City Council considered the evidence and testimony submitted in the public hearing and considered adoption of the Consolidated Plan; and,

WHEREAS, the City desires to amend its Citizen Participation Plan to add reference numbers throughout the document where applicable to the Federal regulations; and,

WHEREAS, the City desires to adopt the Consolidated Plan and amend the previously adopted Citizen Participation Plan.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the Consolidated Plan, attached hereto as **Exhibit A** and incorporated herein by reference, is hereby adopted and approved by the City as its 2020-2024 CDBG Consolidated Plan, and the Mayor is hereby authorized to execute the same on behalf of the City.

SECTION 2. That the Citizen Participation Plan as amended, attached hereto as **Exhibit B** and incorporated herein by reference, is hereby adopted and approved by the City as its CDBG Citizen Participation Plan, to be included in the Consolidated Plan, and the Mayor is hereby authorized to execute the same on behalf of the City.

SECTION 3. That the Mayor, elected officials and City staff are hereby authorized to take such further action, and to execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance and to

implement the Consolidated Plan and the amended Citizen Participation Plan as allowed and required by applicable State and Federal laws and regulations.

SECTION 4. That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

SECTION 5. That this Ordinance shall be in full force and effect from and after the date of its passage and approval.
