AN ORDINANCE APPROVING THE USE OF THE MID AMERICA COUNCIL OF PUBLIC PROCUREMENT COOPERATIVE JOINT VEHICLE BID FOR THE PURCHASE OF CITY FLEET VEHICLES FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS BETWEEN CLAY COUNTY, MO AND KANSAS CITY FREIGHTLINER (CONTRACT NO. 2020-009-1), LANDMARK DODGE (CONTRACT NO. 2020-009-2), OLATHE FORD (CONTRACT NO. 2020-009-3), ROBERTS CHEVROLET (CONTRACT NO. 2020-009-4), AND SHAWNEE MISSION FORD (CONTRACT NO. 2020-009-5) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit (the "City") currently uses various fleet vehicles including cars and trucks, and,

WHEREAS, Section 6.1 of the Procurement Policy allows the City to competitively bid items in a cost effective and efficient manner with other governmental agencies; and,

WHEREAS, the City is able to purchase the needed vehicles pursuant to a contract between Clay County, lead agency, and the following car dealerships: Kansas City Freightliner, Shawnee Mission Ford, Olathe Ford, Landmark Dodge, and Roberts Chevrolet (collectively "Cooperative Contract No. 2020-009"); and,

WHEREAS, Section 4.4 of the Procurement Policy requires that cooperative contracts that have an estimated annual spend of \$50,000.00 or more be approved by City Council before they are used; and,

WHEREAS, the City anticipates spending over \$50,000.00 annually through this on the purchase of fleet vehicles.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the Mid America Council of Public Procurement Joint Vehicle Bid, Clay County, lead agency, with selected dealers, Contract #49-19 (referred to as "Cooperative Agreement"), Kansas City Freightliner (Contract No. 2020-009-1), Landmark Dodge (Contract No. 2020-009-2), Olathe Ford (Contract No. 2020-009-3), Roberts Chevrolet (Contract No. 2020-009-4), and Shawnee Mission Ford (Contract No. 2020-009-5) a copy of which is on file with the City Clerk's Office and incorporated herein by reference, and authorizes the City Manager to execute an agreement by and between the City and awarded dealers, pursuant to the Cooperative Agreement, to purchase fleet vehicles, on an as-needed basis, listed in the Cooperative Agreement.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
