ORDINANCE NO. 4599

AN ORDINANCE DECLARAGE THE RESULTS OF THE APRIL 7, 1998, GENERAL ELECTION FOR MUNICIPAL OFFICERS, "ID QUESTION FOR HOTEL/MOTEL LICENSE TAX FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, an election for municipal officers and the question of whether to impose a license tax on certain gross receipts of hotels, motels and similar places of business, was held in the City of Lee's Summit, Missouri, on April 7, 1998; and,

WHEREAS, notice has been received from the Jackson County Board of Election Commissioners of the results of said election, to be certified by that board; and,

WHEREAS, certification has been received from the Election Authority of Cass County of the results of said election.


