AN ORDINANCE VACATING AN APPROXIMATELY 60' X 375' SEGMENT OF RIGHT-OF-WAY ACROSS 1601 SW M-150 HWY, IN THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the right-of-way was dedicated by separate document and recorded by the Jackson County Recorder of Deeds office by instrument #2016-E-0064431, and,

WHEREAS, Application #PL2019-397, submitted by Journey Church International, requesting vacation of the right-of-way, was referred to the Planning Commission to hold a public hearing; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for the request on January 9, 2019, and rendered a report to the City Council containing findings of fact and recommending that the requested vacation of right-of-way be approved; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on February 4, 2019, and rendered a decision to vacate said right-of-way.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the following described right-of-way is hereby and herewith vacated:

ATRASCT OF LAND, 60.00 FEET WIDE, BEING LOCATED IN SECTION 36, TOWNSHIP 47 NORTH AND RANGE 32 WEST, THE CENTERLINE BEING MORE PARTICULARY DESCRIBED AS FALLOWS:

COMMENCING AT THE NORTH ¼ CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 36; THENCE NORTH 87° 45' 12" WEST ALONG SOUTH LINE OF THE NORTH ½ OG THE NORTHWEST ½ OF SAID SECTION 36, A DISTANCE OF 1153.04 FEET; THENCE SOUTH 02° 12' 18" WEST, A DISTANCE OF 251.82, SAID POINT BEING THE POINT OF BEGINNING OF THE 60.00 FOOT EASEMENT BEING 30.00 FEET ON EATHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE; THENCE SOUTH 88° 11' 57" EAST, A DISTANCE OF 383.47 FEET, SAID POINT BEING THE POINT OF TERMINATION. TRACT CONTAINS 23,019.82 SQ. FT. OR 0.528 ACRES.

SECTION 2. That the following conditions of approval apply:

1. The vacation of right-of-way shall not become effective until such time as new right-of-way is dedicated in a manner acceptable to the City.

SECTION 3. That the City Clerk be and is hereby authorized and directed to acknowledge a copy of this ordinance and to record same in the Office of the Recorder of Deeds for the County in which the property is located.
