AN ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND WALTER P. MOORE AND ASSOCIATES, INC., IN AN AMOUNT NOT TO EXCEED \$171,000 FOR PROFESSIONAL ENGINEERING SERVICES FOR MAIN STREET IMPROVEMENTS FROM CHIPMAN ROAD TO COMMERCE DRIVE AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME.

WHEREAS, the City intends to employ engineering services for the Main Street Improvements from Chipman Road to Commerce Drive Project (hereinafter "Project"); and,

WHEREAS, an Engineer has submitted a proposal for the Project and an estimate of engineering costs to perform the Project; and,

WHEREAS, the Engineer represents that the firm is equipped, competent, and able to undertake such an assignment; and,

WHEREAS, the City Manager is authorized and empowered by the City to execute contracts providing for professional engineering services; and,

WHEREAS, the Engineer was selected based on expertise, knowledge of the Project area, and relevant work previously completed for the Project; and,

WHEREAS, the City desires to enter into an agreement with the Engineer to perform the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the agreement, for professional engineering services contract by and between the City of Lee's Summit, Missouri and Walter P. Moore and Associates, Inc. generally for the purpose of professional engineering services for the Main Street Improvement between Chipman Road and Commerce Drive Project (Sole Source), a true and accurate copy being attached hereto and incorporated herein by reference is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
