AN ORDINANCE APPROVING AMENDMENT NO. 9 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, AS ADOPTED BY ORDINANCE NO. 8643 AND ORDINANCE NO. 8652, BY AMENDING THE AUTHORIZED EXPENDITURES AND REVISING THE AUTHORIZED AMOUNT OF FULL TIME EQUIVALENTS IN THE POLICE DEPARTMENT AND PUBLIC WORKS-OPERATIONS DEPARTMENT FOR THE CITY OF LEE'S SUMMIT, MISSOURI, AND ESTABLISHING A NEW PAY AND CLASSIFICATION PLAN.

WHEREAS, Ordinance No. 8643 and Ordinance No. 8652, passed by the City Council on June 11, 2019, adopted the authorized expenditures and amount of full time equivalents for the City of Lee's Summit; and,

WHEREAS, the Police Department has identified an expansion opportunity for one additional Police Officer; and,

WHEREAS, all expenses associated with the Police Officer expansion position are intended to be funded through an agreement with the Jackson County Drug Task Force; and,

WHEREAS, the amended changes to the expenditures and full time equivalents for the Police Department are outlined in Exhibit A; and,

WHEREAS, approval of this amendment will also create and authorize two new positions: (1) Public Works Operations Supervisor and (2) Public Works Operations Contract Specialist; and,

WHEREAS, to meet the current needs of the Public Works-Operations Department it is necessary to reclassify a Streets Operations Supervisor to a Public Works Operations Supervisor, and reclassify an Administrative Assistant to a Public Works Operations Contract Specialist; and,

WHEREAS, the amended changes to the expenditures and full time equivalents for the Public Works-Operations Department are outlined in Exhibit B; and,

WHEREAS, the addition of the two new positions in the Public Work-Operations Department requires the City's pay and classification plan to be updated.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2020, of the City of Lee's Summit, Missouri, are amended in the following manner:
