AN ORDINANCE APPROVING TERM EXTENSIONS UNTIL DECEMBER 31, 2020 FOR CERTAIN PUBLIC SERVICE AGREEMENTS BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND THE LEE'S SUMMIT CHAMBER OF COMMERCE, INC.; DOWNTOWN LEE'S SUMMIT MAIN STREET; LEE'S SUMMIT ECONOMIC DEVELOPMENT COUNCIL; AND, VELOCITY LEE'S SUMMIT, INC., FOR THE PURPOSES STATED IN EACH AGREEMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit ("City") currently has Public Service Agreements for various services with the Lee's Summit Chamber of Commerce (approved via Ordinance Nos. 8172 and 8173); Downtown Lee's Summit Main Street (approved via Ordinance No. 8174); Lee's Summit Economic Development Corporation (approved via Ordinance No. 8175); and Velocity Lee's Summit (approved via Ordinance No. 8432); and,

WHEREAS, the City and each of the listed community partner agency wish to continue the services outlined in the Public Service Agreements, but due to the current public health crisis, the parties need additional time and information to draft new, long term agreements; and,

WHEREAS, the City wishes to amend the Public Services Agreements to extend the term of the current agreements until December 31, 2020 to provide appropriate time for all parties to develop new agreements; and,

WHEREAS, under the proposed amendments, the City's payments for services contemplated by each agreement will prorated for the length of the extension of the respective Public Service Agreements

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The amendment to extend the term of the public service agreement between the City and the Lee's Summit Chamber of Commerce for marketing services until December 31, 2020, attached as Exhibit A and incorporated herein by reference, is approved, and the City Manager is authorized to execute an amendment in substantially the same form as the attached by and on behalf of the City.

SECTION 2. The amendment to extend the term of the public service agreement between the City and the Lee's Summit Chamber of Commerce for tourism services until December 31, 2020, attached as Exhibit B and incorporated herein by reference, is approved, and the City Manager is authorized to execute an amendment in substantially the same form as the attached by and on behalf of the City.

SECTION 3. The amendment to extend the term of the public service agreement between the City and the Downtown Lee's Summit Main Street until December 31, 2020, attached as Exhibit C and incorporated herein by reference, is approved, and the City Manager is authorized to execute an amendment in substantially the same form as the attached by and on behalf of the City.

SECTION 4. The amendment to extend the term of the public service agreement between the City and the Lee's Summit Economic Development Council until December 31, 2020, attached as Exhibit D and incorporated herein by reference, is approved, and the City Manager is authorized to execute an amendment in substantially the same form as the attached by and on behalf of the City.

SECTION 5. The amendment to extend the term of the public service agreement between the City and Velocity Lee's Summit, Inc. until December 31, 2020, attached as Exhibit E and incorporated herein by reference, is approved, and the City Manager is authorized to execute an amendment in substantially the same form as the attached by and on behalf of the City.

SECTION 6. All other terms of the public service agreements shall remain unchanged and are hereby ratified subject to this Ordinance.

SECTION 7. This Ordinance shall be in full force and effect from and after the date of its passage and approval.

SECTION 8. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
