## **BILL NO. 20-68**

AN ORDINANCE APPROVING THE AWARD OF BID FOR PROJECT NO. 422-C FOR THE SW 3<sup>RD</sup> STREET IMPROVEMENTS FROM PRYOR ROAD TO MURRAY ROAD TO RADMACHER BROTHERS EXCAVATING COMPANY, INC. IN THE AMOUNT OF \$4,638,738.10, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT OF THE SAME AND CONTAINING AN EMERGENCY CLAUSE.

WHEREAS, pursuant to the Thoroughfare Master Plan and Bill No. 17-81, Olsson designed improvements along 3<sup>rd</sup> Street from Pryor Road to Murray Road to address existing and long term operational demand; and

WHEREAS, the project will enhance safety and operations by reconstructing the current threelane road as a four-lane facility with left turn lanes where appropriate for access management; adding street lighting; and, by adding a traffic signal at the intersection of 3<sup>rd</sup> Street and Murray Road; and

WHEREAS, Public Works Engineering issued bids for Project No. 422-C on February 14, 2020; and

WHEREAS, Radmacher Brothers Excavating Company, Inc., was determined to be the lowest and best responsive bidder by City staff; and

WHEREAS, the adoption of this Ordinance relates to the immediate preservation of the public property, safety, and economic development.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby authorizes the award of bid for Project No. 422-C to Radmacher Brothers Excavating Company, Inc., in the amount of \$4,638,738.10.

SECTION 2. That the agreement attached hereto as "Exhibit A" by and between the City of Lee's Summit, Missouri, and Radmacher Brothers Excavating Company, Inc. is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Council hereby declares this Ordinance to be an emergency ordinance and may be passed on its day of introduction in order to immediately preserve public property, safety and economic development through timely completion of this vital infrastructure that was delayed by the cancellation of prior Council Committee and Council meetings due to the initial outbreak of COVID-19, and is an emergency within the meaning of Section 3.13(f)(1) of the Charter of the City of Lee's Summit, Missouri.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
