AN ORDINANCE AUTHORIZING EXECUTION OF MODIFICATION NO. 1 TO THE ON-CALL AGREEMENT FOR ENVIRONMENTAL PROFESSIONAL ENGINEERING SERVICES WITH STEARNS, CONRAD AND SCHMIDT, CONSULTING ENGINEERS, INC. DBA SCS ENGINEERS (RFQ NO. 2020-061), FOR A NOT TO EXCEED COST OF \$232,300.00, FOR ANNUAL TASKS ASSOCIATED WITH THE RESOURCE RECOVERY PARK, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME.

WHEREAS, City and Engineer entered into an agreement for on-call environmental engineering services with SCS Engineers (RFQ No. 2020-061) (Base Agreement); and,

WHEREAS, The City is required to submit regular regulatory reports to the Missouri Department of Natural Resources (MDNR); and,

WHEREAS, City and Engineer desire to modify Articles I and IV of the Base Agreement to provide specific services required to be completed in FY21 for the landfill and establish a not to exceed rate for those tasks and services.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby approves Modification No. 1 to the On-Call Agreement for environmental professional engineering services for the City's Resource Recovery Park, by and between the City of Lee's Summit and Stearns, Conrad and Schmidt, Consulting Engineers, Inc. dba SCS Engineers, generally for reporting to the Missouri Department of Natural Resources related to the City owned landfill at Resource Recovery Park, attached hereto and incorporated by reference as if fully set forth herein, for a not to exceed amount of \$232,300.00, and authorizes the execution of the same by the City Manager on behalf of the City of Lee's Summit.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
