AN ORDINANCE APPROVING APPLICATION #PL2020-*** - UNIFIED DEVELOPMENT ORDINANCE (UDO) AMENDMENT CHANGES TO ARTICLE 6- USE STANDARDS TO ALLOW FOR COMMERCIAL ACCESSORY STRUCTURES SUCH AS OUTDOOR VENDING MACHINES.; CITY OF LEE'S SUMMIT, APPLICANT.

WHEREAS, the Unified Development Ordinance (UDO) was originally adopted by the City Council as Ordinance No. 5209 on September 6, 2001, which has been amended numerous times and recodified in its entirety by the adoption of Ordinance No. 8443 and is incorporated into the City's Code of Ordinances through Section 33-1 of the Code; and,

WHEREAS, Application # PL2020-*** proposing amendments to an ordinance approving application #PL2020-*** - Unified Development Ordinance (UDO) amendment changes to Article 6- Use Standards to allow for commercial accessory structures such as outdoor vending machines; and

WHEREAS, the Community and Economic Development Committee considered the proposed ordinance approving application #PL2020-*** - Unified Development Ordinance (UDO) amendment changes to Article 6- Use Standards to allow for commercial accessory structures such as outdoor vending machines; and on March 25, 2020, authorized the amendments to be advertised for public hearings; and

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for Application # PL2020-*** on April 9, 2020 and rendered a report to the City Council recommending that the proposed ordinance approving - Unified Development Ordinance (UDO) amendment changes to Article 6- Use Standards to allow for commercial accessory structures such as outdoor vending machines; and be approved, and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on Application # PL2020-*** on April 28, 2020 and,

WHEREAS, the City Council determined that the proposed UDO amendment contained in Application # PL2020-*** would serve the interests of the citizens of Lee's Summit.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as shown on the attached copy, appended hereto and made a part hereof.

SECTION 1. That changes to Article 6- Use Standards to allow for commercial accessory structures such as outdoor vending machines; and, are hereby amended in the manner shown on the copy appended hereto as Exhibit "A" and incorporated herein by reference.

SECTION 2. That it is the intention of the City Council and is hereby ordained that the provisions of this Ordinance shall become and be made a part of the UDO, and the sections of this Ordinance and the UDO may be renumbered as appropriate to accomplish such intention.

SECTION 3. That this ordinance shall be in full force and effect from and after the date of its passage, adoption, and approval by the Mayor.
