## BILL NO. 20-107

AN ORDINANCE APPROVING THE USE OF THE COOPERATIVE CONTRACT, LS CONTRACT 2018-097, FOR INSTALLATION OF CAST IN PLACE PIPE (CIPP) AND LATERAL CONNECTION REPAIRS (LCR) IN AN AMOUNT NOT TO EXCEED \$900,000 AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAME ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to rehabilitate its sewer lines and lateral connections; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity but have extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to purchase Cast In Place Pipe (CIPP) and Lateral Connection Repairs(LCR) from Ace Pipe Cleaning, through its City of Joplin Cooperative Contract, which is LS Contract 2018-097; and,

WHEREAS, Section 6.1 of the Procurement Policy requires a cooperative contract that has an estimated annual spend of \$50,000.00 or more be approved by City Council before it is used; and,

WHEREAS, the City anticipates spending over \$900,000 this year through the purchase of CIPP lining and LCR installations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the City of Joplin's agreement with Ace Pipe Cleaning Inc., Contract #00500 (referred to as "Cooperative Contract No. 2018-097"), attached as Exhibit A and incorporated herein by reference, for installation of cast in place pipe (CIPP) and lateral connection repairs (LCR) and authorizes the City Manager to execute documents necessary to allow the use of said Cooperative Contract, known as LS Contract 2018-097.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
