B. 2020-3509 Update on the Quality Housing Program

Dan Harper, Assistant Director of Field Services, provided an update on the Quality Housing Program. A pilot program was started in January 2020 which included sending program information to developers and HOA's through various media resources. However, the program was placed on hold in March 2020 due to the COVID-19 crisis. In the meantime, staff will continue the community media outreach to increase awareness about the program.

C. 2020-3496 Public Hearing: Amendment to CDBG Citizen Participation Plan

Amy Koeneman, Administration Manager, Development Services, reviewed the current CDBG citizen participation process and explained the requested amendment to the CDBG Citizen Participation Plan based on the CARES Act (due to the COVID-19 crisis) and the timeline. She explained the amendment would have no impact on the CDBG disbursements already approved.

Mayor Pro Tem Lopez made a motion to recommend to City Council approval of the amendment to the CDBG Citizen Participation Plan, seconded by Vice Chair DeMoro.

The motion passed unanimously.
