AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 324-20/21 (CURB) TO PHOENIX CONCRETE & UNDERGROUND LLC IN THE AMOUNT OF \$2,130,805.26, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the City's annual Curb Repair Program includes, but is not limited to, removal and replacement of concrete curb and gutter, concrete sidewalks, driveway approaches, and placement of ADA-compliant curb ramps, generally on streets that are scheduled for overlay the following year; and,

WHEREAS, the 20/21 Curb Repair Program will replace 81,500 lineal feet of curb and renovating 123 sidewalk ramps to comply with the ADA ("Project No. 324-20/21 (Curb))"; and,

WHEREAS, the City publicly advertised an invitation to bid for the Project; and,

WHEREAS, Phoenix Concrete & Underground LLC ("Contractor") was determined to be the lowest and most responsive bidder by City staff; and,

WHEREAS, the City desires to enter into an agreement with the Contractor to perform the Curb Repair Program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 324-20/21 (Curb) to the Contractor in the amount of \$2,130,805.26.

SECTION 2. That the agreement attached hereto as "Exhibit A" by and between the City of Lee's Summit, Missouri, and the Contractor is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
