AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN METROPOLITAN COMMUNITY COLLEGE OF KANSAS CITY (MCC) AND G&C RESTORATION, LLC, DBA SERVPRO OF LEE'S SUMMIT, TO PURCHASE DISASTER RECOVERY SERVICES AS NEEDED AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to purchase disaster recovery services on as needed basis; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity but have extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to purchase disaster recovery services pursuant to a contract between Metropolitan Community College of Kansas City and G&C Restoration LLC, ("Cooperative Contract No. 2020-071"); and,

WHEREAS, Section 6.1 of the Procurement Policy requires that cooperative contracts that have an estimated annual spend of \$50,000 or more be approved by City Council before they are used; and,

WHEREAS, the City anticipates spending over \$50,000.00 if the services are needed to respond to a disaster.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the Metropolitan Community College of Kansas City disaster recovery contract with G&C Restoration LLC, Contract #19-7242-C2R3 (referred to as "Cooperative Agreement"), a copy of which is on file with the Procurement Division of the Finance Department and incorporated herein by reference, and authorizes the City Manager to execute an agreement by and between the City and G&C Restoration, LLC, attached as Exhibit A and incorporated herein by reference, to purchase disaster recovery services from G&C Restoration, LLC.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
