AN ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND WSP USA FOR 3RD STREET IMPROVEMENTS FROM JEFFERSON STREET TO BLUE PARKWAY (RFQ NO. 2020-066) FOR AN AMOUNT NOT TO EXCEED \$647,300.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the City intends to employ engineering services for the 3rd Street Improvements from Jefferson Street to Blue Parkway Project (hereinafter "Project"); and,

WHEREAS, an Engineer has submitted a proposal for the Project and an estimate of engineering costs to perform the Project; and,

WHEREAS, the Engineer represents that the firm is equipped, competent, and able to undertake such an assignment; and,

WHEREAS, the City Manager is authorized and empowered by the City to execute contracts providing for professional engineering services; and,

WHEREAS, the Engineer was selected based on a qualifications based selection (RFQ No. 2020-066); and,

WHEREAS, the City desires to enter into an agreement with the Engineer to perform the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the agreement, for professional engineering services contract by and between the City of Lee's Summit, Missouri and WSP USA generally for the purpose of professional engineering services for the 3rd Street Improvements between Jefferson Street and Blue Parkway Project (RFQ No. 2020-066) for an amount not to exceed \$647,300.00, a true and accurate copy being attached hereto and incorporated herein by reference as "Exhibit 1", is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
