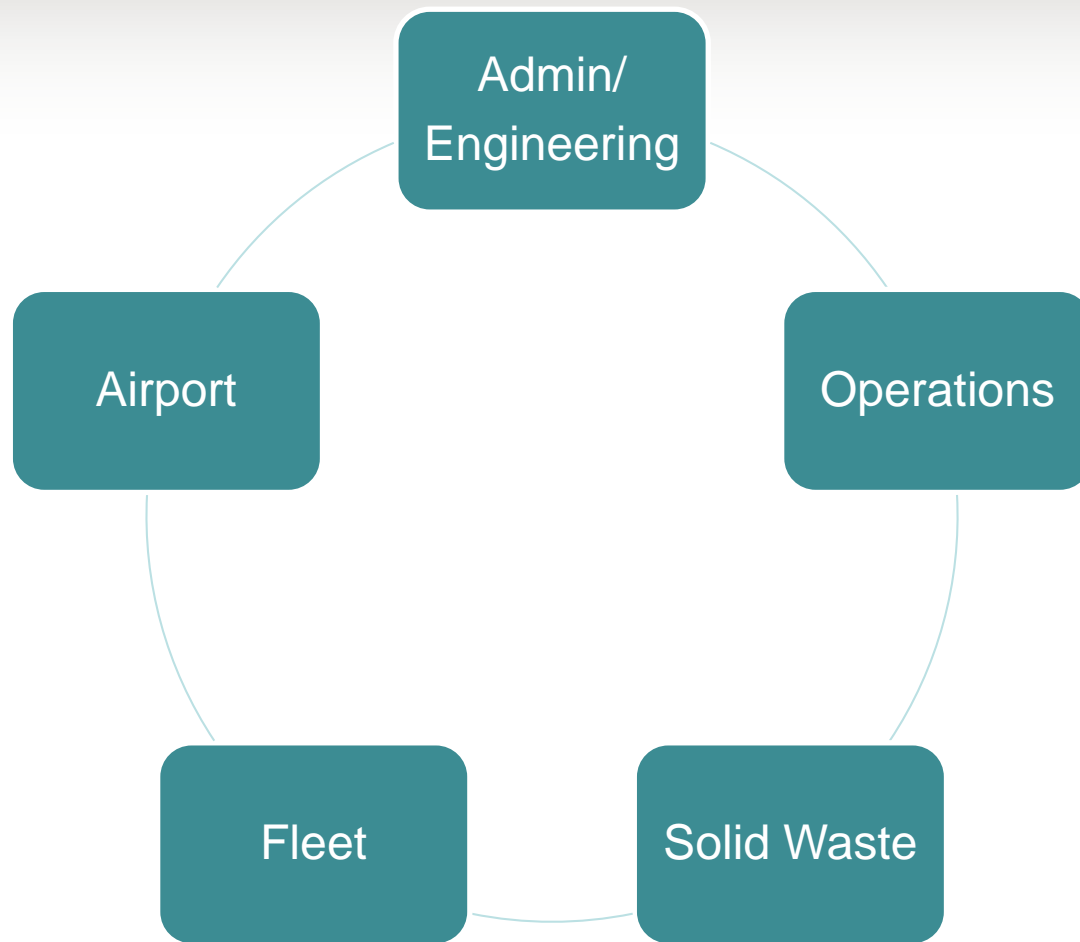

APWA Accreditation

- APWA began the accreditation program in 1996 to “enhance the effectiveness of agencies and their competencies in the public works field.”
- LSPW was accredited in 2004 as the 16th agency in the U.S.
- There are approximately 150 APWA Accredited agencies.
- Agencies are re-accredited every four years. LSPW has been re-accredited in 2008, 2012 & 2016.
- LSPW is directly responsible for 27 Chapters identified in the 9th edition of the *Public Works Management Practices Manual*.

Public Works Airport Division

The Public Works Airport Division is responsible for the daily operation of the Lee's Summit Municipal Airport (LXT).



Aviation Services Provided at LXT

- Stationary and mobile refueling
- Hangar rental
- Aircraft towing
- Car rental
- Crew cars
- Office space

Services Provided by Others at LXT

- Aircraft inspections and maintenance
- Aircraft rental
- Airplane rides
- Light Sport Aviation

Public Works Engineering Division

The Engineering Division provides the City with technical expertise for managing the City's infrastructure from concept through construction.

- Capital Projects
- Traffic & Transportation
- Water, Stormwater & Sanitary Sewer Engineering
- Construction Management & Inspections



Fleet Division

- In July 2019, Fleet became a division of Public Works.
- Staff of 6 mechanics, Superintendent, Shop Supervisor and clerical support
- Responsible for the purchase, maintenance and sale of 458 city vehicles
- Completes approximately 1,651 work orders a year
- Total annual repair cost was \$587,600
- Fleet vehicles drive approximately 2,050,800 miles per year
- Total annual fuel cost was \$480,800
- Responsible for fuel storage and dispensing

Public Works Operations Division



Public Works Operations maintains the city's infrastructure through:

- Repair of City streets and sidewalks
- Street sweeping
- Snow and ice removal
- Maintenance of public drainage facilities
- Mowing of property in the City's right-of-way

The Operations Division maintains more than 1,039 lane miles of roadway, which is equivalent to a single-lane road from Lee's Summit to Washington D. C.

Public Works Solid Waste Division

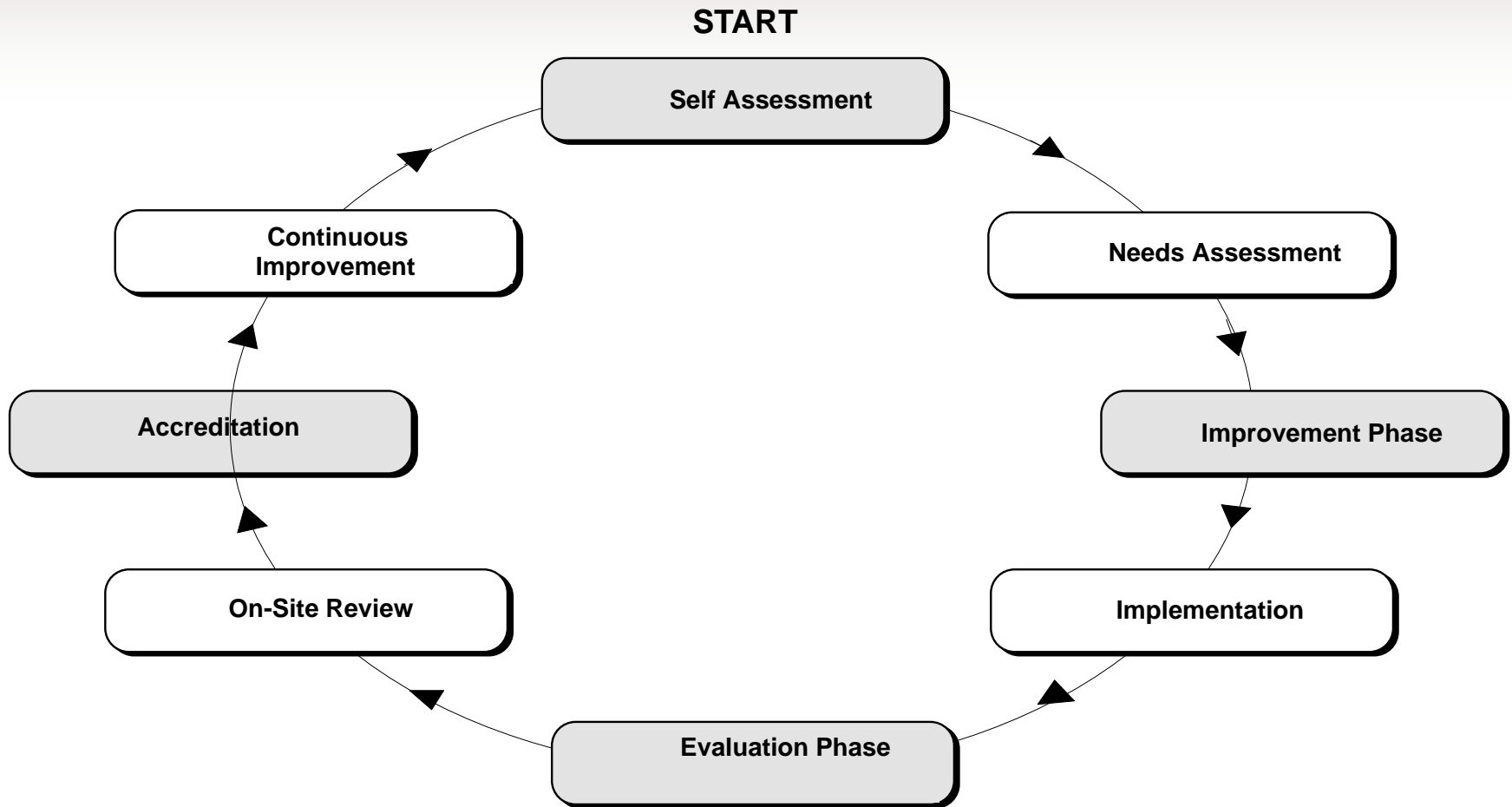
- In April 2019, the City's Landfill reached its permitted capacity.
- A private company is operating the public disposal area (PDA) to continue solid waste disposal services to private individuals.
- The City is exploring the possibility of having a transfer station on the site, and continues oversight, compliance, and post-closure of the City's landfill.
- Responsible for the long-term care and maintenance of the site.

APWA Accreditation

Accreditation provides a mechanism to:

- Evaluate the organization
- Improve effectiveness
- Encourage documentation of policies and procedures
- Foster cross-training and interaction among staff
- Instill staff and community with pride

The APWA Accreditation Process



Accreditation = Continuous Improvement

- Accreditation is an ongoing process tied to the daily operations of LSPW.
- Continuous improvements is sought by all LSPW staff in implementing and updating practices, policies and procedures of the agency.

- Accreditation is a department-wide effort that engages staff from all five divisions
- Chapter Leaders are responsible for ensuring the agency is in full compliance with all of the identified management practices in their chapters.
