AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2020-002, FOR THE ANNUAL MEDICAL PHYSICALS OF ALL SWORN FIREFIGHTERS TO SITEMED NORTH AMERICA, LLC FOR AN INITIAL TERM OF ONE-YEAR WITH UP TO FOUR, ONE-YEAR RENEWALS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the Fire Department offers physicals to all sworn members, and the physicals are to follow the national standard issued by the National Fire Protection Association, Standard 1582, which outlines an occupational medical program that will reduce risks and provide for the health, safety, and effectiveness of firefighters operating to protect civilian life and property; and,

WHEREAS, the Fire Department understands its most valuable asset is its employees and in order to keep a well maintained employee force it must be able to provide a mechanism in which the physical and mental health of its employees are evaluated annually; and,

WHEREAS, RFP No. 2020-002 was sent to the Fire Department vendor list and advertised through the City's e-procurement system, Public Purchase; and,

WHEREAS, of the two proposals received, SiteMed North America, LLC scored the highest.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council of Lee's Summit hereby authorizes the award of RFP No. 2020-002 to SiteMed North America, LLC for the annual physicals of all sworn firefighters.

SECTION 2. The agreement by and between the City and SiteMed North America, LLC for the annual physicals of all sworn firefighters for an initial term of one-year with up to four, one-year renewals in an annual amount not to exceed \$65,000, attached as Exhibit A and incorporated by reference, is hereby approved, and the City Manager is authorized to execute such agreement by and on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
