AN ORDINANCE APPROVING AMENDMENT NO. 2 TO THE BUDGET FOR FISCAL YEAR ENDING JUNE 30, 2021, AS ADOPTED BY ORDINANCE NO. 8905 AND ORDINANCE NO. 8906, BY AMENDING THE AUTHORIZED EXPENDITURES IN VARIOUS CATEGORIES TO PROVIDE FOR THE SPENDING OF CARES ACT FUNDS ALLOCATED TO THE CITY.

WHEREAS, the President of the United States, the Governor of the State of Missouri, and the Mayor of the City of Lee's Summit (the "City"), have each declared a state of emergency in response to the 2019 novel coronavirus ("COVID-19"); and,

WHEREAS, on March 27, 2020, the United States enacted the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") which established the Coronavirus Relief Fund (the "Fund") and appropriated \$150 billion to the Fund; and,

WHEREAS, Jackson County, Missouri (the "County") received \$122.7 million from the Fund, and the County, through Ordinance 5372, has appropriated approximately \$36.9 million of its CARES Act funding to the cities within its borders; and

WHEREAS, the County appropriated to the City an amount not to exceed \$5,921,527.00, and the City may receive its entire appropriation upfront upon the County's approval of the City's budget for spending the funds; and,

WHEREAS, under the CARES Act, the money may only be used to cover costs that: (1) are necessary expenditures incurred due to the public health emergency with respect to COVID–19; (2) were not accounted for in the budget most recently approved as of March 27, 2020 for the City; and (3) are incurred between March 1, 2020, and December 30, 2020; and,

WHEREAS, the City plans to execute an intergovernmental agreement with the County to accept its appropriation of CARES Act funding in response to the COVID-19 pandemic; and

WHEREAS, Ordinance No. 8905 and Ordinance No. 8906, passed by the City Council on June 16, 2020, adopted the authorized expenditures for the City; and,

WHEREAS, the expenditures attributable to the CARES Act funds were not included within the FY21 budget; and,

WHEREAS, the City must amend the budgeted expenditures to account for the additional expenses covered by the CARES Act funds.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2021, of the City of Lee's Summit, Missouri, are amended follows:
