AN ORDINANCE APPROVING MODIFICATION NO. 1 TO AN AGREEMENT DATED JULY 16, 2019 (RFQ# 543-32272B) FOR PROFESSIONAL ENGINEERING SERVICES FOR STORMWATER – SE HACKAMORE DRIVE & SE SECRETARIAT DRIVE BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND INTUITION & LOGIC, INC., FOR AN INCREASE OF \$179,867.00 WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$259,644.20, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 8666, the City entered into an Agreement dated July 16, 2019 (RFQ# 543-32272B) for Professional Engineering Services for Stormwater – SE Hackamore Drive & SE Secretariat Drive with Intuition & Logic, Inc. (hereinafter "Base Agreement"); and,

WHEREAS, under the Base Agreement, Intuition & Logic, Inc. (hereinafter "Contractor") evaluated possible alternatives to address structural flooding of properties along SE Hackamore Drive and SE Secretariat Drive; and,

WHEREAS, the City desires to modify the Base Agreement that would allow the Contractor to develop plans for the most cost-effective and advantageous of those alternatives (hereinafter "Modification No. 1"); and,

WHEREAS, funding for this project is authorized from the Capital Projects Sales Tax Fund that was approved by voters in April 2017 and became effective on April 1, 2018; and,

WHEREAS, following the Engineer's completion of conceptual studies, the City desires for the Engineer to proceed with the project design described in this contract modification to complete the stormwater project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby approves Modification No. 1 for an increase of \$179,867.00 with an amended not to exceed amount of \$259,644.20, as attached hereto as "Exhibit 1".

SECTION 2. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the execution, by the City Manager, of Modification No. 1.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
