

BILL NO. 20-171

AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 324-20/21 (CRACK SEAL) FOR THE CRACK SEAL 20/21 PROGRAM TO AMERICAN PAVEMENT SOLUTIONS, INC. IN THE AMOUNT OF \$218,700.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, crack sealing minimizes the probability of potholes by sealing cracks greater than 1/8" and protecting the pavement sub-grade from excessive moisture, thereby extending the life of a pavement system; and,

WHEREAS, the Crack Seal 20/21 Program will seal cracks along 54.5 lane miles (hereinafter "Project No. 324-20/21 (Crack Seal)"); and,

WHEREAS, Public Works Engineering issued a bid for Project No. 324-20/21 (Crack Seal) on August 14, 2020, in accordance with local policies and state statutes; and,

WHEREAS, American Pavement Solutions, Inc. ("Contractor") was determined to be the lowest and best bidder by City staff; and,

WHEREAS, the City desires to enter into an agreement with the Contractor to perform the 20/21 Crack Seal Program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 324-20/21 (Crack Seal) to the Contractor in the amount of \$218,700.00.

SECTION 2. That the agreement attached hereto as "Exhibit A" by and between the City of Lee's Summit, Missouri, and the Contractor is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
