AN ORDINANCE APPROVING MODIFICATION NO. 2 TO AN AGREEMENT DATED AUGUST 15, 2019 (RFQ No. 543-32272D) FOR PROFESSIONAL ENGINEERING SERVICES FOR STORMWATER IMPROVEMENTS – 5 LOCATIONS BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND BURNS & MCDONNELL ENGINEERING COMPANY, INC., FOR AN INCREASE OF \$39,930.00 WITH A NOT TO EXCEED AMOUNT OF \$246,540.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 8690, the City entered into an Agreement dated August 15, 2019 (RFQ# 543-32272D) for Professional Engineering Services for Stormwater Improvements – 5 Locations with Burns & McDonnell Engineering Company, Inc. (hereinafter "Base Agreement"); and,

WHEREAS, under the Base Agreement, Burns & McDonnell Engineering Company, Inc. (hereinafter "Engineer") provided stormwater evaluations and professional engineering design services to address structural flooding of properties along NE Maple Street, SE Grand Avenue, SE Bingham Drive and SE Brentwood Drive; and,

WHEREAS, the City desires to modify the Base Agreement that would allow the Engineer to provide engineering support during the construction phase of the project (hereinafter "Modification No. 2"); and,

WHEREAS, the project was approved by City Council in the FY2019 Capital Improvement Plan, and funding is authorized from the Capital Projects Sales Tax Fund that was approved by voters in April 2017 and became effective on April 1, 2018.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby approves Modification No. 2 for an increase of \$39,930.00 with a not to exceed amount of \$246,540.00, as attached hereto as "Exhibit 1".

SECTION 2. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the execution, by the City Manager, of Modification No. 2.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
