

BILL NO. 20-215

AN ORDINANCE APPROVING AMENDMENT NO. 3 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2021, AS ADOPTED BY ORDINANCE NO. 8905 AND ORDINANCE NO. 8906, BY AMENDING THE AUTHORIZED EXPENDITURES IN THE WATER TAP FUND AND WATER CONSTRUCTION FUND FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 8905 and Ordinance No. 8906, passed by the City Council on June 16, 2020, adopted the authorized expenditures and amount of full time equivalents for the City of Lee's Summit; and,

WHEREAS, Lee's Summit Water Utilities has a development agreement with Woods Custom Homes for the extension of a 12" water main to Woodlawn Estates located in southwest corner of the intersection of U.S. Route 50 and Missouri Route 7; and,

WHEREAS, the work will be completed by Lee's Summit Water personnel with the exception of possible fence replacement and concrete road patching; and,

WHEREAS, this work was not anticipated during the creation of the current Capital Improvements Plan or the budget for the current fiscal year; and,

WHEREAS, the budget amendment will amend the authorized expenditures in the Water Tap Fund and Water Construction Fund to include funds for the water main extension.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2021, of the City of Lee's Summit, Missouri, are amended in the following manner:

SECTION 2. All other provisions of Ordinances No. 8905 and No. 8906 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8937) and Amendment No. 2 (Ordinance No. 8941).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.
