AN ORDINANCE APPROVING MODIFICATION NO. 1 TO AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR STORMWATER – SW LEA DRIVE (RFQ# 543-32272A) BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND OLSSON AND ASSOCIATES, FOR AN INCREASE OF \$25,795 WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$234,251, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 8665, the City entered into an Agreement for Professional Engineering Services for Stormwater – SW Lea Drive (RFQ# 543-32272A) with Olsson and Associates, Inc. (hereinafter "Base Agreement"); and,

WHEREAS, under the Base Agreement, Olsson and Associates, Inc. (hereinafter "Contractor") would provide engineering services to address elevated flood risk to properties along SW Lea Drive; and.

WHEREAS, during final design, the Engineer and City Staff confirmed a potential conflict between the proposed RCB and the existing water main; and

WHEREAS, the City desires to modify the Base Agreement that would allow the Contractor to design for the relocation of the existing water main (hereinafter "Modification No. 1"); and,

WHEREAS, funding for this project is authorized from the Capital Projects Sales Tax Fund that was approved by voters in April 2017 and became effective on April 1, 2018.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby approves Modification No. 1 for an increase of \$25,795 with an amended not to exceed amount of \$234,251, as attached hereto as "Exhibit 1".

SECTION 2. That the City Council of the City of Lee's Summit, Missouri, hereby authorizes the execution by the City Manager of Modification No. 1.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
