Executive Summary

1. Introduction

On March 27, 2020 the United States Congress passed The Coronavirus Aid, Relief, and Economic Security Act also known as the *CARES Act*. The bill provided \$5 billion for Community Development Block Grant Program (CDBG) to rapidly respond to COVID-19 at a local level. The purpose of this Substantial Amendment is to include additional funding as a result of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

The City of Lee's Summit will receive \$219,061 in CDBG-CARES (CDBG–CV) funding. A Substantial Amendment to the FY 2020-21 Annual Action Plan is required as this was not included in the original approval of the FY 2020-21 Action Plan.

In September 2020, the City was notified it would receive an additional allocation of \$352,711 in CDBG-CV funds to help the community continue responding to the coronavirus pandemic. To use these funds, a secondary substantial amendment to the 2020-21 Annual Action Plan is required.

To allow for expedited use of the CDBG-CV funding, the U.S. Department of Housing and Urban Development (HUD) has created several waivers for communities to utilize. These include eliminating the cap on funds a grantee can spend on public services, removing the requirement to hold in-person public hearings in order to comply with national and local social gathering requirements, and allowing grantees to be reimbursed for COVID-19 response activities, if certain CDBG requirements were met.

The CDBG-CV funds allocated under the CARES Act may be used for a range of eligible activities that prevent, prepare and respond to COVID-19. The proposed activities must meet the three National Objectives as required by CDBG regulations:

- Benefit low-and-moderate income persons.
- Aid in the prevention or elimination of slums or blight, and
- Meet an urgent need.

Pursuant to HUD regulations, the City's Citizen Participation Plan has been amended to allow for program specific waivers. This Substantial Amendment was available for public review and comment for

a period of five days. Notice of this review period, as well as notice of the public hearing was published in the Lee's Summit Tribune and on the City's website.

This Action Plan covers the program year 2020-2021, the initial year of the 2020-2024 Consolidated Plan (Con Plan) period of the Community Development Block Grant Program. Through the Con Plan, the following needs were identified as high priority:

- Sidewalks and curbing in established neighborhoods
- Connection of neighborhood sidewalks to parks/trails
- Storm drains in older neighborhoods
- Long term transitional housing
- Housing affordability: renters and owners
- Maintenance of established neighborhoods
- Rental inspections
- Home ownership counseling
- Transportation barriers
- Accessibility to basic needs and services (food, shelter, clothing)
- Access to and affordability of mental/behavioral Health
- Street maintenance and additional street lighting on neighborhood streets
- Access to affordable daycare

The 2020-21 Action Plan continues to reflect a local partnership between City government and not-forprofit services and housing agencies. With these partnerships, the goals and objectives established in the Con Plan will be implemented. The standard public process established in the City's Citizen Participation Plan including a public awareness campaign was followed. This included the solicitation of CDBG funding requests from local services and housing agencies, evaluation and prioritization of funding needs, a public hearing, a 30-day public review and comment period, and the approval of the governing body.

The recommended funding allocations focus on sustaining on-going programs that have proven to address the critical needs of the community as identified in the Con Plan. CDBG funds also help agencies to leverage other resources in support of their programs. Funded programs on the non-public-service side focus on the preservation of the community's affordable housing.

Due to limited funding from this program, not all of the priority needs identified in the Con Plan are addressed by the programs funded this program year. Local agencies are urged to explore alternative resources to support and expand their programs.

2. Summarize the objectives and outcomes identified in the Plan

Through this plan and its commitment of financial support, the City strives to accomplish the following objectives:

- continue supporting the agencies and programs that have received CDBG funding in prior years in order to help them maintain a similar level of service;
- continue to support the agencies and programs benefiting low income families;
- continue to support services for children exposed to domestic violence and adults with mental health and substance abuse issues; and,
- continue to provide financial assistance to LMI homeowners for the upkeep of their homes through a home preservation program and to the local public housing agency to implement its CIP.

The outcomes will benefit a total of about 3,352 individuals and households, and improve 81 affordable housing units.

3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

The majority of the programs included in this Action Plan have been funded and in operation for several years. The majority of the agencies offering these programs and services utilizing the CDBG funds have proven to be solid in terms of their performance as well as their impact on the community's well-being. The City has a monitoring and evaluation system in place to determine subrecipient performance levels. This is taken into account during the evaluation and prioritization of funding allocation.

In program year 2019-20, the City funded a Development Specialist position for Lee's Summit Housing Authority (LSHA). While this was the first year the City funded the position, LSHA had a difficult time finding the right person for the role given the amount of money the City awarded the position, therefore the role has not had much impact on the community to-date. Due to the amount of funding the City has available for program year 2020-21, and the desires expressed by the committee and City Council to recover staff costs, staff did not recommend funding this position.

On February 22, 2020, a public notice was published in the Lee's Summit Tribune announcing the Community and Economic Development Committee (CEDC) public hearing scheduled for March 11, 2020. This hearing provided citizens an opportunity to hear funding proposals from local agencies, as well as staff funding recommendations, public comments, and the prioritization of the proposals. Once Annual Action Plan

heard, committee discussions occur and recommendations are established for consideration by the full City Council.

On March 11, 2020, the City Council Community and Economic Development Committee held a public hearing on the draft 2020-21 Action Plan and funding allocation proposals based on the 2020-21 grant award announced by HUD in February of 2020 (\$372,384) as well as re-allocation proposals of funds remaining from prior year programs and projects in the amount of \$21,067. The CEDC slightly reduced staff's funding recommendation of CDBG Program Administration in order to fully fund the Lee's Summit Housing Authority Duncan Estates Exterior Rehab project. No other changes were made to the Action Plan or funding recommendation and the CEDC approved a recommendation for the City Council adoption of the Action Plan.

A 30-day public review and comment period began on March 13 and ran through April 17. Hard copies of the Action Plan were made available for public access at two local public libraries, The Gamber Center, and City Hall locations. The draft Action Plan was also made available on the City's website. Due to the outbreak of COVID-19, City facilities closed to the public on March 24th. Per HUD regulations, the 30-day public comment period was reduced to not less than 5 days. Access to our draft plan remained available on the City's website through April 17th. No public comments were received by the City.

On April 28, 2020 the final Action Plan was presented to City Council and adopted by ordinance.

First Substantial Amendment to Annual Action Plan

The public outreach and consultation process for this Action Plan Amendment consists of a public awareness campaign via press release, solicitation of requests for funding, public hearing and a 5-day public review and comment period.

City Accepting Applications for Community Development Block Grants for COVID-19 Relief

The City of Lee's Summit is currently accepting applications from qualified agencies through June 5 for Community Development Block Grant (CDBG) funding specifically allocated to provide relief to low-to-moderate income individuals affected by the COVID-19 pandemic. Through the Coronavirus Aid, Relief, and Economic Security Act, the City will receive \$219,061 from the U.S. Department of Housing and Urban Development.

Applications are available at cityofLS.net/development. Applicants must show a direct increase in service need as a result of the COVID-19 pandemic and verify no other state or federal funding is available to meet those needs. All proposals must comply with applicable requirements and regulations.

Qualified agencies include public agencies and nonprofit organizations. For-profit organizations may also be eligible for consideration if the proposed programs or projects serve a public purpose. Individuals are not eligible to apply.

Applications should be submitted to <u>cdbg@cityofls.net</u> no later than 5 p.m. on June 5. For questions about the application and/or eligibility requirements, contact Sarah Tilbury at 969-1243 or email <u>Sarah.Tilbury@cityofLS.net</u>.

A notice was publish in the Lee's Summit Tribune on June 20, 2020, advertising that a public hearing on the draft substantial amendment would take place on July 8, 2020 at the City Council Community and Economic Development Committee meeting.

The draft substantial amendment to the FY 2020-21 Annual Action Plan was available for public review from July 9, 2020 – July 13, 2020. The document was available on the City's website at www.cityofls.com/developmentservices, and hard copies were provided upon request. The public review period was posted on the City's website, and published in a local newspaper. No public comments were received.

On July 21, 2020 this amendment was presented to City Council and adopted by ordinance.

Second Substantial Amendment to the Annual Action Plan

The public outreach and consultation process for this Action Plan Amendment consists of a public awareness campaign via public hearing and a 5-day public review and comment period.

A Notice of Public Hearing was published in the Lee's Summit Tribune on November 21, 2020. The notice specifically stated:

• A public hearing would be held on December 9, 2020 to discuss a proposed amendment that would allow City staff to administer and allocate funding to qualifying agencies as needs arise within Lee's Summit

1. Introduction

The City of Lee's Summit Development Services department coordinates the consultation process for the Community Development Block Grant Program 2020-24 Con Plan and the subsequent Annual Action Plans. The consultation process for the Annual Action Plan includes a community awareness campaign through the City's press release, newspaper advertising and a public hearing, which is followed by a public review and comment period.

The City actively works with both local and regional agencies to meet community needs. This has included work within consultation, strategic planning, and financial support through the CDBG program. Through the annual CDBG action plan process, the City works with these agencies to identify priority needs, service gaps, as well as overlap of services to ensure critical services receive funding priority.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

Lee's Summit is a part of the service area of the Greater Kansas City Coalition to End Homelessness (GKCCEH), the designated regional Continuum of Care (CoC) serving the Jackson County, Missouri area and has been working with the network over the years as needed.

In evaluating the role of Lee's Summit in addressing homelessness, GKCCEH and their embrace of the Housing First approach were considered as a means of assessment. Effective attainment of this approach can be measured by the implementation of policy and provision of funding that ultimately leads to the creation of permanent and sustainable housing for all homeless individuals. Lee's Summit will also continue to support allocating funding toward residential minor home repair improvements, and the City is exploring options that may increase the number of residents benefitting from the program.

Within Lee 's Summit, there are many services in the community that are supported by the City in their efforts to actively prevent and reduce homelessness.

The following programs will contribute to the prevention of homelessness:

- Hope House: An emergency shelter in Lee's Summit that serves victims of domestic violence, including children
- ReDiscover Mental Health: Provides mental health services to individuals as well as families in different settings
- Hillcrest Transitional Housing: Works to house homeless individuals, families, and youths in an environment that encourages working and the development of life skills
- Lee's Summit Social Services: Provides emergency assistance to low-to moderate-income individuals and families
- Lee's Summit Housing Authority: Local public housing agency

Annual Action Plan

A press release was posted on December 19, 2019. The press release stated:

- Applications for the 2020-21 CDBG program year would be available on January 6, 2020;
- Applications would be accepted from January 6 through February 7, 2020; and
- A public hearing would take place for applicants to present their programs to the City Council Community and Economic Development Committee

A legal notice was published in the Lee's Summit Tribune on February 22, 2020 announcing the public hearing would take place on March 11, 2020. A 30-day comment period began on March 13, 2020 and concluded on April 17, 2020. This timeframe allowed citizens to review and provide comments on the 2020-21 AAP. The plan was made available for review in hard copy at City Hall, the Gamber Center and Lee's Summit branches of Mid-Continent Public Library, as well as online via the City's website. Due to the outbreak of COVID-19, City facilities closed to the public on March 24th. Per HUD regulations, the 30-day public comment period was reduced to not less than 5 days, so the City was able to maintain compliance. While public facilities were closed, access to the City's draft plan remained available on the City's website through April 17th. No public comments were received by the City and the final plan was read and adopted by City Council on April 28, 2020.

Introduction

The City has been informed it will receive \$372,384.00 in federal funds for fiscal year 2020-21. At this time, these are the only funds the city expects to allocate to achieving Con Plan objectives. Local agencies will have opportunities to apply for the ESG grant through the State of Missouri. Public housing needs may also be met with other HUD grants to be awarded to the Lee's Summit Housing Authority. Local agencies will continue to make efforts and explore new funding sources for their programs to meet client needs.

Under the CARES Act, the City received \$219,061 in funding to prepare, prevent and respond to the COVID-19 pandemic. In continued response to the COVID-19 pandemic, the City will receive a second allocation of \$352,711 in CARES Act funding to prepare, prevent and respond to COVID-19.

Introduction

This program year, Lee's Summit continues to support existing on-going public service programs by maintaining the current level of CDBG funding. On the Public Service side, all funding requests are met with the capped amount of the annual grant of \$372,384. The City plans to continue investing in a Minor Home Repair or Home Preservation Program with the goal of helping more LMI households and freeing up City staff time to manage the overall program. The City continues to work with Lee's Summit Housing Authority to make needed upgrades of its residential units for sustainability, safety and efficiency.

The City of Lee's Summit received \$219,061 in CDBG-CV funds. To assist in addressing the increased demand for services and need for personal protective equipment, the City is proposing to allocate CDBG funds to local public service agencies. The additional funding is expected to assist at least 300 low-income households and assist providers in securing protective equipment required in order to continue providing services.

The City of Lee's Summit received \$352,711 in additional CDBG-CV funds. This funding will be allocated to qualifying agencies and projects within Lee's Summit as needs arise. The number of beneficiaries may vary based on the services funded; but will aid to those most in need.

Discussion

The City's purpose is to serve those individuals and areas that have been identified within the Con Plan. This does not focus on a certain area of the City, but rather a population of people. The City and it's supported projects assist people within the community, so long as the individual is a resident of Lee's Summit.

The City identified two different Geographic Distribution Target Areas for the purpose of the Consolidated Plan: Old Town Area and Communitywide. However, the programs and services to be supported through the CDBG program target the populations that the CDBG program is designed for, without an obvious emphasis on the geographic locations of the clients. As shown above, the City intends to allocate funding for programs and services that do not specifically have a geographic focus. However, most of these programs and services benefit the population located in the Old Town Area or areas adjacent to the this part of the city.

- Build relationships with partners
- Apply for additional rental vouchers (as they may become available through HUD) and actively administrate the Section 8 Housing Choice Voucher Program.
- Explore leveraging public and private funds to create additional housing opportunities
- Collaborate with the City of Lee's Summit, Jackson County, other for-profit and non-profit organizations in the development of affordable housing
- Collaborate with the Lee's Summit Economic Development Council
- Employ effective management and maintenance policies

Actions to encourage public housing residents to become more involved in management and participate in homeownership

The Lee's Summit Housing Authority has a Resident Housing Commissioner appointed to serve on the Board of Housing Commissioners. Resident Commissioner is a welcomed addition to the Housing Authority Board of Commissioners and brings a unique perspective and insight to the Board. The Lee's Summit Housing Authority keeps open communications with the residents though a monthly newsletter and twice monthly pot-luck dinners. Residents are also engaged by LSHA management and Board Members. The Lee's Summit Housing Authority maintains an "open door" policy for residents to voice their concerns.

If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

The Lee's Summit Housing Authority is designated a High Performing Agency by HUD through its Public Housing Management Assessment and Section Eight Management Assessment Programs. LSHA is not designated as "troubled".

Discussion

Many of the strategies and goals for long-term viability and objectives for addressing the needs of the Lee's Summit Housing Authority and the greater Community are taken directly from the information, strategies and objectives identified in the City of Lee's Summit Consolidated Plan and as may also be identified in additional "Studies" such as the Old Lee's Summit Development Master Plan and Housing Affordability Analysis 2014, Vogt Strategic Insights 2017, Lee's Summit Affordable Housing Needs Assessment by University of Kansas Urban Planning Students UBPL: 710 Fall of 2017, Census Data, and

related market studies.

Many of the physical and operational improvements identified in LSHAs 5-Year Plan are contingent upon current and future funding through the CDBG Program, HUD Funding (CFP & OPFND) and, PILOT waiver by the City.

Many of the strategies to address the need for developing affordable housing opportunities and solutions for the growing Senior population, Veterans and low to moderate income families is dependent upon cooperation by the City of Lee's Summit, the Business Community, Private and Public Investment and the greater Community support.

AP-65 Homeless and Other Special Needs Activities – 91.220(i)

Introduction

For the 2020-21 Action Plan, the City anticipates supporting the homeless and special needs population by providing continued financial support to local public services such as Hope House, ReDiscover, Coldwater, Hillcrest and Lee's Summit Social Services. These agencies all continue to provide critical services to Lee's Summit residents with special needs.

Coldwater of Lee's Summit has requested funds to continue the support of the "BackSnack Program". This program provides nutritional needs of hungry children. Hope House, ReDiscover, Hillcrest Transitional Housing and Lee's Summit Social Services provide varied services pertaining to the mental health of low-to-moderate income individuals, those experiencing homelessness or those effected by domestic violence.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Homeless shelter services are provided by the CoC of the Greater Kansas City region. In addition, Hillcrest Transitional Housing operates 18 shelter units in Lee's Summit. Our focus is on providing financial assistance to local public service agencies that target residents who are temporarily homeless due to domestic violence or who are potentially becoming homeless due to mental health issues. Activities receiving CDBG assistance this program year that help reduce chances of people becoming homelessness include services provided by Hope House, ReDiscover, and Coldwater. In addition, CDBG funding is provided to Hillcrest Transitional Housing to provide case management counseling services to its Lee's Summit client families. The City will coordinate and work with CoC for its outreach and assessment efforts.

Addressing the emergency shelter and transitional housing needs of homeless persons

The City plans to continue providing financial support to local agencies through CDBG funds. These agencies, which include Hope House, Hillcrest Transitional Housing and Lee's Summit Social Services, offer support to those currently experiencing homelessness or experiencing displacement due to domestic violence situations. While the City does not directly receive ESG funds, local non-profits are encouraged to apply for these funds as an additional source of funding.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that

individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City continues to work with the regional CoC, as well as coordinating efforts with Lee's Summit Social Services. Local churches often provide similar services without any assistance from CDBG, but nonetheless play an important role in helping homeless individuals and families make the transition to permanent housing.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

Prevention initiatives play a key role in both long and short term strategies to address homeless prevention and counseling for the families they serve. In the 2020-21 program year, the City will direct CDBG funds to several of these programs to alleviate budget shortage. In the meantime, CDBG support will also benefit local agencies and programs that provide services targeting LMI persons and persons with special needs for housing, health, and other social services.

Discussion

The City's CDBG funding distribution process is a competitive one where the City opens funding request opportunities to all local agencies that provide services to meet the priority goals of the Consolidated Plan. Agencies file funding requests based on financial support needs and funding allocations decisions are based on priorities, agency capacities and funding availability.

AP-75 Barriers to affordable housing – 91.220(j)

The City provides financial opportunities through the CDBG program for agencies to provide housing choices and home repairs to benefit persons with housing burdens.

In 2019, the City completed its Analysis of Impediments to Fair Housing Choice (AI) project. Based upon this, it does not appear that there is sufficient housing for those of extremely low to moderate income households. This has also been identified through the Con Plan, and is being addressed through projects funded by CDBG.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment.

AP-85 Other Actions - 91.220(k)

Introduction:

Coordination of services is extremely important to ensure services are provided efficiently and effectively, especially when resources are scarce. While developing the 2020-2024 Consolidated Plan, three focus groups were formed to discuss Public Service needs, Housing needs, and Infrastructure needs. This opportunity allowed businesses, residents and members of the community to join and talk through specific challenges and identify community needs.

Actions planned to address obstacles to meeting underserved needs

The major obstacle to meeting underserved needs is limited funding. The City will continue to encourage public service agencies to actively explore and pursue new funding opportunities. The City will also continue to explore and participate in regional solutions to some of the underserved needs.

Actions planned to foster and maintain affordable housing

Funded programs and projects though CDBG for housing related repairs and rehabilitation meet the goal of sustaining the community's affordable housing stock and improving the conditions. In an effort to increase the number of clients served, the City has been exploring a new way of operating the Minor Home Repairs Program in order to help more residents.

Actions planned to reduce lead-based paint hazards

Continue to educate the public regarding the danger of lead-based paint hazards. Continue to enforce the requirement for residential rehabilitation contractors to be properly licensed when taking on residential rehabilitation projects.

Actions planned to reduce the number of poverty-level families

The City continues to promote economic development to improve the economic health of the community and its citizens by:

- Increase business activities
- Expand job training and employment opportunities
- Foster small business and startups
- Invest in needed public infrastructure improvement for economic development
- Encourage and incentivize business expansion and new business activities
- Continued to support private agencies for services to help poverty-level population to get on

their feet

Actions planned to develop institutional structure

The City will continue to improve the institutional structure to better serve the needs of the community. Inter-agency coordination will continue to be the focus in order to improve efficiency and avoid duplication of efforts. This year, the City is conducting another round of its strategic planning that involves extensive public involvement to help the City identify priority needs of this community and strategies to meet those needs. This process will certainly help to further strengthen the effort of a community working together to tackle community issues. In early 2020, the City also began working on developing a new comprehensive plan, which will be an extensive, multi-year process involving a lot of inter-agency coordination.

Actions planned to enhance coordination between public and private housing and social service agencies

- Continue to provide training for agencies receiving CDBG funding
- Continue to encourage agencies, private or public, to communicate and coordinate
- Continue to monitor CDBG subrecipients on performance and provide technical support as needed
