AN ORDINANCE AUTHORIZING THE EXECUTION OF A MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION SUPPLEMENTAL AGREEMENT TO AIRPORT AID AGREEMENT FOR PROJECT NO. 136-109A-1 BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION, GRANTING STATE FUNDS IN THE AMOUNT OF \$883.00 AND FOR EXTENDING THE GRANT EXPIRATION DATE TO DECEMBER 30, 2020 FOR ASSISTING WITH RUNWAY 11-29 PREGRADING AT THE LEE'S SUMMIT MUNICIPAL AIRPORT.

WHEREAS, the parties entered into an Agreement executed by the Sponsor on September 30, 2013, and executed by the Commission on October 8, 2013 (hereinafter, "Original Agreement"), to assist with the relocation of the airport access road and runway 11-29 pregrading; and,

WHEREAS, the Lee's Summit Municipal Airport received a grant for \$31,457.00; and,

WHEREAS, the project is in the process of being closed out; and,

WHEREAS, this amendment provides for granting additional funds in the amount of \$883.00 and extends the grant expiration date from December 30, 2014 to December 30, 2020; and,

WHEREAS, in order to close the project and received all available grant funds, this amendment must be approved by the City Council.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby authorizes the execution by the Mayor of a Missouri Highways and Transportation Commission Supplemental Agreement to Airport Aid Agreement for Project No. 136-109A-1 by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, granting state funds in the amount of \$883.00 and for extending the grant expiration date to December 30,2020 for assisting with runway 11-29 pregrading at the Lee's Summit Municipal Airport.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
